- 1. The Local Government Unit of Loon, Bohol through its appropriation from the general fund intends to apply the sum of **Two Million Twenty-Five Thousand Pesos** (**P 2,025,000.00**), being the Approved Budget for the Contract [ABC], to payment under the contract for the **Purchase & Installation of Remote Sensing Monitoring System Phase II** following by way of Competitive Bidding of Republic Act No, 9184, otherwise known as the "Government Procurement Reform Act" [IRR/RA No. 9184].
- 2.0 The Local Government Unit of Loon, Bohol now invites bids for the project below:

- 3.0 Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4.0 Interested bidders may obtain further information from the Office of the Bids and Awards Committee [BAC], through the BAC Secretariat, Municipal Hall, Loon, Bohol, and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M., Monday to Friday.
- 5.0 A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of ₱ 5,000.00.
- 6.0 In addition to Class "A" and Class "B" Eligibility Criteria of IRR/RA No. 9184, Bidders should have completed within 2 years from the date of submission and receipt of bids, a contract at least one similar project. The description of an eligible bidder is contained in the Bidding Documents particularly, in Section II, Instruction to Bidders.
- 7.0 Bids must be delivered to the address on or before <u>September 11, 2024, at 8:30 AM</u> at the Office of the Bids and Awards Committee, Conference Room, Municipal Hall, Cogon Norte, Loon, Bohol. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids will not be accepted
