CREATING THE MUNICIPAL GRIEVANCE AND REDRESS COMMITTEE (MGRC) FOR A MORE RESPONSIVE AND TIMELY PROVISION OF RECOMPENSE TO PERSONS AFFECTED BY THE CONSTRUCTION OF AN "AA" ABATTOIR IN THE MUNICIPALITY OF LOON UNDER THE PHILIPPINE RURAL DEVELOPMENT PROJECT

WHEREAS, the construction of an "AA" abattoir in the Municipality of Loon, particularly in the Barangay of Basac, is funded by the Philippine Rural Development Project (PRDP);

WHEREAS, in the implementation of the project, complaints and grievances may surface from the immediate community or other aggrieved parties, thus requiring the resolution of such issues and concerns by a committee tasked to perform responsive roles and functions;

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:

Section 1. Creation and Composition. - In regard to the construction of an AA abattoir in the Municipality of Loon under the Philippine Rural Development Project, the Municipal Grievance and Redress Committee is hereby created, as follows:

Section 2. Roles and Functions. - The Municipal Grievance and Redress Committee shall have the following roles and functions:

- 2a. To deliberate issues and concerns, particularly complaints and grievances that are related to the construction of an "AA" abattoir in the Municipality of Loon;
- 2b. To resolve issues on compensation for persons whose property may be affected by the slaughterhouse project; and

- 2c. To endorse to the Provincial Grievance and Redress Committee any unresolved issues for the latter to decide upon.

Section 3. Meetings. - The Municipal Grievance and Redress Committee shall meet at least once a month. If the Chairperson is not available, the vice chairperson or any representative designated by the former shall preside. The Secretariat shall ensure that all members of the Committee are informed of the schedule and agenda of the meeting.

Section 4. Funds. - Funds for the programs, project and activities undertaken by the Municipal Grievance and Redress Committee shall be provided by or charged to the Office of the Mayor.

Section 5. Effectivity. - This Executive Order shall take effect immediately.
