ENJOINING ALL DEPARTMENTS AND OFFICES TO ADOPT AND APPLY THE PROJECT MONITORING AND MANAGEMENT SYSTEM (PMMS) AS AN AUTOMATED IN-HOUSE INFORMATION AND COMMUNICATION TECHNOLOGY SYSTEM OF THE LOCAL GOVERNMENT UNIT OF LOON

WHEREAS, Republic Act No. 9485 mandates all government agencies to improve the delivery of public service to reduce bureaucratic red tape and prevent graft and corruption;

WHEREAS, Republic Act No. 10173, also known as the Data Privacy Act of 2012, aims to protect personal data in information and communication systems, in both government and private sectors, and created the National Privacy Commission to monitor the enforcement of the Act;

WHEREAS, the LGU of Loon adopts and implements the Commission on Audit Circular No. 2013-004 dated January 30, 2013 entitled "Information and Publicity on Programs/Projects/Activities of Government Agencies";

WHEREAS, the LGU of Loon hired Information Technology (IT) personnel to develop automated systems that led to the systematic processing of data for the benefit of all concerned departments, offices and other constituents;

WHEREAS, in line with the LGU's commitment to good governance, the Project Monitoring and Management System (PMMS) was designed to be a transparent, accountable and efficient system for conveniently tracking the proposed, on-going and completed projects of the LGU in the different barangays;

WHEREAS, as an automated information and communication technology system, PMMS was installed in the LGU management system in July 2017, after which it resulted in improved efficiency, accuracy and convenience owing to its easy access;

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:

**Section 1.** All departments and offices are hereby enjoined to use the PMMS, or the Project Monitoring and Management System, as an automated in-house information and communication technology system of the Local Government Unit of Loon.

**Section 2.** The personnel and staff of the Municipal Information and Communication Technology Office (MICTO) shall take charge of the in-house dissemination, monitoring, maintenance and updating of the PPMS and other ICT systems of the LGU.

**Section 3.** The LGU shall provide updated ICT equipment to address and adapt to the fast-changing technology innovations and to minimize any system malfunction.

**Section 4.** The Executive Order shall take effect immediately.
