RECONSTITUTING THE MUNICIPAL PEACE AND ORDER COUNCIL

WHEREAS, the Municipal Peace and Order Council shall, at all times, actively participate in the development of harmonized and holistic programs, projects and activities for the Local Government Unit of Loon;

WHEREAS, it is the duty of local governments, the law enforcement agencies, the prosecution services, and similar government institutions to assist the Local Chief Executive in the proper enforcement of the law and the administration of justice;

WHEREAS, the Municipal Peace and Order Council of the Local Government Unit of Loon was reconstituted through Executive Order No. 18 issued on September 12, 2022;

WHEREAS, the composition of the current Municipal Peace and Order Council needs to be updated;

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:

Section 1. Reconstitution of the Municipal Peace and Order Council. - The MPOC shall be reconstituted, as follows:

Section 2. Functions. - The MPOC shall have the following functions:

- 2a. Formulate a three-year Local Peace and Order Council Public Safety Plan, to be incorporated into the Comprehensive Development Plan;
- 2b. Recommend strategic actions or activities aimed at promoting, improving or enhancing peace and order and public safety measures, including anti-insurgency measures within the Municipality of Loon;
- 2c. Monitor the implementation of peace and order programs and projects of the LGU of Loon and such other counterinsurgency programs and activities; and
- 2d. Perform such other functions, duties and responsibilities that may be assigned by higher-level peace and order councils.

Section 3. Creation of the MPOC Special Action Committee. - There shall also be created an MPOC Special Action Committee, to be composed of the following:

Section 4. Functions of the MPOC Special Action Committee. - The MPOC Special Action Committee shall perform the following functions:

- 4a. Take the lead in the formulation of the Peace and Order and Public Safety Plan (POPS Plan) of the Municipality of Loon;
- 4b. Address urgent issues concerning peace and order and public safety; and

4c. Prepare and submit a biannual MPOC Accomplishment Report.

Section 5. Creation of the MPOC Secretariat. - The MPOC Secretariat shall also be created, to be composed of the following:

Section 6. Functions of the MPOC Secretariat. - The MPOC Secretariat shall perform the following functions:

- 6a. Assist the MPOC Chairperson in the conduct of MPOC meetings;
- 6b. Provide technical assistance in the performance of administrative and technical tasks;
- 6c. Prepare the proceedings of the MPOC meetings, like Council resolutions and minutes of meetings; and
- 6d. Monitor the functionality of the Barangay Peace and Order Councils and submit an annual BPOC Functionality Report.

Section 7. MPOC Meetings and Quorum. - Section 103 of the Local Government Code of 1991 provides that the MPOC shall meet every first Friday of the month at 2:00 p.m. or as often as necessary. A majority of the members of the MPOC shall constitute a quorum, provided that the Chairperson or Vice Chairperson must be present during meetings where budgetary proposals are being prepared or presented and considered. The affirmative vote of the majority of the members of the Council shall be necessary to approve such proposals.

Section 8. Effectivity. - This Order shall take effect immediately and shall remain in force and effect unless repealed by the undersigned.
