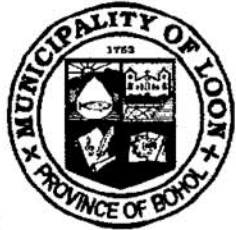

DESIGNATION OF ONE (1) ANTI-DRUG ABUSE COUNCIL (ADAC) FOCAL PERSON AND ONE (1) ALTERNATE ADAC FOCAL PERSON IN THE MUNICIPALITY OF LOON

WHEREAS, the Constitution mandates that the government shall promote the quality of life of the people;

WHEREAS, Section 2 of the Comprehensive Dangerous Drugs Act or Republic Act No. 9165 declares that it is the policy of the State to safeguard the integrity of its territory and the well-being of its citizenry particularly the youth, from the harmful effects of dangerous drugs on their physical and mental well-being, and to defend the same against acts or omissions detrimental to their development and preservation;

WHEREAS, DILG - Dangerous Drugs Board (DDB) Joint Memorandum Circular No. 2018-01 provides that Local Government Units (LGUs) shall designate two (2) focal persons, preferably holding plantilla positions and are members of the Municipal Anti-Drugs Council, for the Anti-Drug Abuse Council-Reporting System (ADAC-RS), as operated by the Dangerous Drugs Board;

WHEREAS, DILG Memorandum dated February 28, 2024 provides that during the Regional Oversight Committee for Barangay Drug Clearing Special Meeting on February 27, 2024, it was agreed that there should be designated focal persons to assist the Barangay Anti-Drug Abuse Councils (BADACs) in complying with the necessary documents for "Drug-Cleared" status to ensure the increase number of drug-cleared barangays in Central Visayas.

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:

Section 1. Designation of Anti-Drug Abuse Council (ADAC) Focal Persons. - Dr. Maria Victoria D. Lamparas, Municipal Health Officer, is hereby designated as ADAC Focal Person of the Municipality of Loon.

Section 2. Designation of Alternate ADAC Focal Person. - Police Major Rey Olar, Chief of Police of the PNP Loon Station, is hereby designated as Alternate ADAC Focal Person.

Section 3. Roles and Responsibilities of the ADAC Focal Person. - The ADAC Focal Person shall perform the following roles and responsibilities:

- 3a. Activate, strengthen and ensure the functionality of the MADACs and the BADACs;
- 3b. Ensure the preparation of the Local Anti-Drug Plan of Action (LADPA);
- 3c. Lead the implementation of the Drug-Free Workplace Program;
- 3d. Cooperate in the establishment of a Drug Abuse Rehabilitation Center and in the implementation of Community-Based Rehabilitation Program for drug surrenderers;
- 3e. Coordinate with government agencies and non-government organizations for the provision of livelihood and training programs to PWUDs;
- 3f. Coordinate with concerned government agencies for Barangay Drug Clearing;

3g. Endorse the names of two (2) encoders who shall assist in recording information in the system; and

3h. Assist and ensure the compliance of BADACs in the Barangay Drug Clearing Program.

Section 4. Roles and Responsibilities of the Alternate ADAC Focal Person. - The Alternate ADAC Focal Person shall perform the following roles and responsibilities:

4a. Assist the ADAC Focal Person in performing her roles and responsibilities; and

4b. In the absence of the ADAC Focal Person, perform the roles and responsibilities of the ADAC Focal Person.

Section 5. Separability Clause. - If any section or part of this Order is declared unconstitutional or invalid, the other sections or provisions of this Order, remains valid.

Section 6. Effectivity. - This Executive Order shall take effect immediately.
