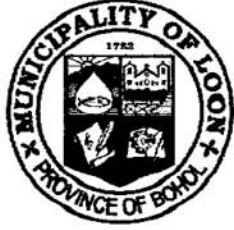

RECONSTITUTING THE MUNICIPAL INVENTORY, DISPOSAL AND AWARDS COMMITTEES

WHEREAS, it is the policy of the State that all resources of the government shall be managed, expended or utilized in accordance with pertinent laws and regulations, and safeguarded against loss or wastage;

WHEREAS, the Local Government Code of 1991 stresses the need for local government units to formulate measures so that such national policy is faithfully adhered to; and authorizes the institution in every LGU of an accountable, efficient and dynamic organizational structure and operating mechanism in the furtherance of its duties, functions and responsibilities and for ensuring its accountability;

WHEREAS, it is within the duties, functions and obligations of the LGU of the Municipality of Loon to keep records of all its property, conduct a regular inventory of the same, and dispose of those that are destroyed, defective or whose continued use is no longer beneficial to the LGU;

WHEREAS, the Municipal Inventory, Disposal and Awards Committees created by virtue of Executive Order No. 11, Series of 2024 need to be reconstituted;

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:

**Section 1.** The Municipal Inventory Committee, Municipal Disposal Committee and Municipal Committee on Awards, are hereby reconstituted, as follows:
