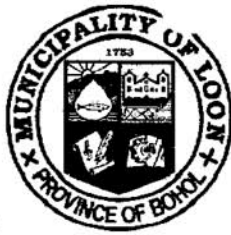

CONSTITUTING THE MUNICIPAL COMPOSITE VALIDATION AND ASSESSMENT TASK TEAM

WHEREAS, the DILG issued Memorandum Circular No. 2024-053 in regard to the nationwide implementation of the Barangay Road Clearing Operations and the assessment, validation and recognition of the BaRCO under the Bagong Pilipinas program;

WHEREAS, in compliance with the directive of the President of the Republic of the Philippines, it is necessary that the conduct of the BaRCO and submission of the corresponding BaRCO Report are regularly undertaken by the officials and personnel of the barangay including officials of the Sangguniang Kabataan;

WHEREAS, the BaRCO compliance shall be jointly assessed and validated by the DILG, PNP, BFP and other concerned government agencies including municipal LGUs, as well as representatives of civil society organizations (CSOs) and/or nongovernment organizations, based on the provisions of DILG MC No. 202027 dated February 07, 2020 and DILG MC No. 2022-085 dated June 20, 2022;

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:

Section 1. Creation and Composition of the Municipal Composite Validation and Assessment Task Team. – The Municipal CVATT is hereby created and shall be composed of the following:

Section 2. Duties and Responsibilities of the Municipal CVATT. - The Municipal CVATT shall perform the following duties and responsibilities:

- 2a. Consolidate and confirm the validation and assessment results of BaRCOs;
- 2b. Rank from highest to lowest the scores of the barangays in the validation and assessment of their BaRCOs;
- 2c. Submit to the DILG Provincial Office the Municipal Consolidated BaRCO Validation and Assessment Result; and
- 2d. For the cross-posting of CVATT, observe the following:
 - 2d1. Conduct on-the-ground validation and assessment in the barangays;
 - 2d2. Check the presence of road obstructions during the actual validation and assessment;
 - 2d3. For every obstruction observed in the barangay road, street or alley, deduct one (1) point from the validation/assessment score;
 - 2d4. Take photographs as means of verification or proof of the cleared status of barangay roads, streets or alleys, or the presence of clutter, obstructions, or illegal installation or construction;
 - 2d5. Duly accomplish and sign the corresponding BaRCO Validation and Assessment Form No. 1 (Annex E) and submit the same to the DILG Provincial Office;
 - 2d6. Provide the Municipal Mayor with a copy of the duly accomplished BaRCO Validation and Assessment Form No. 3 (Annex G); and
 - 2d7. Timely submit the Validation and Assessment Results and List of Top BaRCO Performers.

Section 3. Funding and Other Resources. - The Local Government Unit of Loon shall allocate and utilize available funds for the continuous conduct of road clearing operations and maintenance of the cleared roads, and defray the cost of necessary logistics for the quarterly BaRCO validation and assessment.

Section 4. Repealing Clause. - All orders or issuances inconsistent with the provisions of this Executive Order are hereby repealed or modified accordingly.

Section 5. Effectivity. - This Executive Order shall take effect immediately upon signing hereof.
