EXECUTIVE ORDER NO. 27 Series of 2023

RECONSTITUTING THE MUNICIPAL INVESTMENT PLANNING TEAM FOR HEALTH

Whereas, the Implementing Rules and Regulations of Republic Act 11223, or the Universal Health Care Act, state that the National Government will make available commensurate financial and non-financial grants, including capital outlay, human resources for health and health commodities, in accordance with the approved province-wide and municipality-wide health investment plans;

WHEREAS, DOH Regional Memorandum No. 027-2016 requires a Local Investment Plan for Health (LIPH) for all DOH assistance to Local Government Units;

WHEREAS, Administrative Order No. 2020-0022 requires the organization of a Municipal Investment Planning Team for Health to include non-health staff;

WHEREAS, the Municipal Investment Planning Team for Health, that was organized through Executive Order No. 11 issued on September 5, 2022, needs to be reconstituted;

Now THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Province of Bohol, do hereby declare and order the following:

Section 1. Reconstitution of the Municipal Investment Planning Team for Health. – The Municipal Investment Planning Team for Health shall be reconstituted, as follows:

Section 2. Functions. – The Municipal Investment Planning Team for Health shall have the following functions:

- 2a. Local investment planning for Health (LIPH / Annual Operation Plan);
- 2b. Review and validation of Barangay Investment Plans for Health;
- Preparation of resolution supporting the plan for presentation to and approval by the Local Health Board;
- 2d. Implementation and monitoring of the LIPH/AOP; and
- 2e. Technical assistance for the barangays through the barangay health stations.

Section 3. Schedule of Meetings. – The Municipal Investment Planning Team for Health shall hold semi-annual meetings on dates agreed upon by its members.

Section 4. Effectivity. - This Executive Order shall take effect immediately.
