RECONSTITUTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL

WHEREAS, Section 3, Rule 1 of Republic Act 10121 declares the policies of the state on disaster risk management and climate change, one of which is to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management, and building the resilience of local communities to disasters including climate change impacts;

WHEREAS, the Municipal Disaster Risk Reduction and Management Office was established on September 9, 2022 through Executive Order No. 17, Series of 2022;

WHEREAS, strengthening the country's institutional capacity involves the reconstitution of the Municipal Disaster Risk Reduction and Management Council (MDRRMC);

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:

Section 1. Reconstitution of the Municipal Disaster Risk Reduction and Management Council (MDRRMC). - The MDRRMC shall be reconstituted, as follows:

Section 2. Functions of the MDRRMC. - The MDRRMC shall have the following functions:

- 2.1. Approve, monitor and evaluate the implementation of the Local Disaster Risk Reduction and Management Plan (LDRRMP) and annually review, test and develop the plan consistent with other national and local planning programs;
- 2.2. Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;
- 2.3. Recommend the implementation of forced or pre-emptive evacuation of local residents, if necessary; and
- 2.4. Convene the local council once in every three months on the dates and place to be determined by the body.

Section 3. MDRRMC Meetings. - The MDRRMC shall convene once in every three months on the dates and place to be determined by the body. The Chairperson shall call for a special meeting as he may deem necessary. The Municipal Council shall promulgate their respective internal rules for their meeting.

Section 4. MDRRMC Secretariat. - The Municipal Disaster Risk Reduction and Management Office (MDRRMO) shall serve as the Secretariat of the MDRRMC.

Section 5. Effectivity. - This Executive Order shall take effect immediately.
