**CONSTITUTING THE CITIES AND MUNICIPALITIES COMPETITIVENESS INDEX TECHNICAL WORKING GROUP (CMCI - TWG)**

WHEREAS, the Cities and Municipalities Competitiveness Index (CMCI) is an annual ranking of Philippine cities and municipalities developed by the National Competitiveness Council of the Philippines through the Regional Competitiveness Committees (RCCs) with the assistance of the United States Agency for International Development;

WHEREAS, cities and municipalities in the Philippines are ranked on their competitiveness based on an overall competitiveness score or the sum of scores on five main pillars, namely, economic dynamism, government efficiency, infrastructure, resiliency, and innovation;

WHEREAS, the CMCI can be used as a diagnostic tool by local government officials to assess the competitiveness of their city or municipality, identify areas for improvement and collaboration, and provide insights in policy making, development planning and investment promotion;

WHEREAS, the CMCI can serve as a guide for the business sector in deciding where to locate business establishments, and for the academic community, civil society, tourists and others sectors for their specific concerns;

WHEREAS, in order to systematically collect and generate the complete and accurate data needed in the annual CMCI ranking, there is a need for the formation of a CMCI Technical Working Group in the LGU of Loon;

NOW THEREFORE, premises considered and by virtue of the authority vested upon me under the Local Government Code and other existing laws, I, Elvi Peter L. Relampagos, mayor of the Municipality of Loon, Bohol, do hereby declare and order the following:
