INVITATION FOR NEGOTIATED PROCUREMENT REHABILITATION OF TALISAY FISH PORT

1. The Local Government Unit of Loon, Bohol through its appropriation from the local fund intends to apply the sum of **Six Hundred Fifty Thousand Pesos (₱ 650,000.00)**, being the Approved Budget for the Contract [ABC], to payment under the contract for the **Rehabilitation of Talisay Fish Port** following by way of Competitive Bidding of Republic Act No, 9184, otherwise known as the "Government Procurement Reform Act" [IRR/RA No. 9184].

The Local Government Unit of Loon, Bohol now invites bids for the project below:

2. In view of the two (2) failed public biddings, the Local Government Unit of Loon now invites interested bidders for negotiation for the **Rehabilitation of Talisay Fish Port**. Prospective bidders should have completed a similar project in the past two (2) years. Bids in excess of ABC shall be automatically rejected at bid opening.
3. Bidding will be conducted through negotiated procurement (*after two failed biddings*) using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the Office of the Bids and Awards Committee [BAC], through the BAC Secretariat, Municipal Hall, Loon, and inspect the documents at the address given below from 8:00 A.M. to 5:00 P.M., Monday to Friday.
5. Bids must be delivered to the address on or before **October 7, 2024, at 08:30 AM** at the Office of the Bids & Awards Committee, Municipal Hall, Cogon Norte, Loon, Bohol.
