MUNICIPAL ORDINANCE NO. 24-011 Series of 2024

AN ORDINANCE RECLASSIFYING LOT NO. 3080-B-1 FROM AGRICULTURAL USE TO CEMETERY USE LOCATED AT CUASI, LOON, BOHOL

Be it enacted by the 15th Sangguniang Bayan of Loon, Bohol in session duly assembled that:

SECTION 1. RECLASSIFICATION. There shall be reclassified from agricultural use to cemetery use on Lot No.3080-B-1 with an area of 17,434 square meters located in Cuasi, Loon, Bohol, as per Sketch Plan of Lot No. 3080-B, PSD-07-045563 as prepared for Placido Floren, with corresponding Vicinity Map, herewith attached as Annex A.

SECTION 2. RATIONALE. The following are the reasons for the conversion of lot from agricultural to cemetery use:

- There is an urgent need for the establishment of a Parochial Cemetery of Nuestra Senora de la Paz Y Buen Viaje-Birhen sa Kalinaw ug Maayong Panaw comprising of 7 barangays in the First District of Loon, namely, Song-on, Tontonan, Taytay, Cuasi, Tangnan, Cabadug and Pig-ot.
- The Birhen sa Kasilak Parish has finally ordered for the bodies of the parishioners from the other parish outside of the Kasilak Parish be buried at their respective cemeteries.
- The subject lot has never been used for agricultural use for decades of years being located in rocky areas, and therefore, it is not productive for agricultural use.

- d) The lot-owners who are the Heirs of Placido Floren, et al have agreed to sell such subdivided parcel of lot No. 3080-B-1 in favor of the Diocese of Tagbilaran by virtue of the Extra-Judicial Settlement with Simultaneous Sale, herewith attached as Annex B.

SECTION 3. SUPPORTING DOCUMENTS. The following are the Supporting Documents issued for the reclassification of the subject lot:

- a) Certification from the Municipal Agriculturist – certifying the fact that the lot is no longer productive for agricultural use and has never been cultivated or used as a farm land for decades of years, attached as Annex C.
- b) Initial Permit issued by the Department of Health through the Central Visayas Center for Health Development, re: Initial Permit (Burial Grounds) Permit No. IP-001-Y23 granted to Rev. Fr. Gerald Lopena, Parish Priest, Nuestra Senora de La Paz Y Buen Viaje Parish for the construction of the Parish Cemetery Complex located at Cuasi, Loon, Bohol, Attached as Annex D.
- c) A public hearing has been conducted by the 15th Sangguniang Bayan of Loon, Bohol through the Committee on Land Use, Committee on Public Works and Committee on Health where in the public favorably applauded for such a grandeur project.

SECTION 4. IMPLEMENTING OFFICE. The offices of the Municipal Assessor, Municipal Planning and Development Office, Municipal Building officials, Municipal Health Officer and Municipal Agriculturist shall be the main implementors of this ordinance.


SECTION 5. EFFECTIVITY. This ordinance shall take effect upon its approval.
