AN ORDINANCE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 24-009 AND SECTION 2 OF MUNICIPAL ORDINANCE NO. 24-005 FOR DISSOLVING OF UNFUNDED PLANTILLA POSITIONS AND FUNDING OF UNFUNDED POSITIONS IN THE MUNICIPALITY OF LOON, PROVINCE OF BOHOL

Be it enacted by the 15th Sangguniang Bayan of Loon, Bohol in session duly assembled:

SECTION 1. TITLE. This ordinance shall be known as "An Ordinance Amending Section 3 of Municipal Ordinance No. 24-009 and Section 2 of Municipal Ordinance No. 24-005 for dissolving of unfunded Plantilla Positions and funding of unfunded positions in the Municipality of Loon, Province of Bohol.
