MUNICIPAL ORDINANCE NO. 12-001
Series of 2012

AN ORDINANCE REGULATING THE BUSINESS OF SELLING AND BUYING OF SCRAP IRON, PLASTICS AND OTHER RECYCLABLE / REUSABLE MATERIALS IN ANY BARANGAY OF THE MUNICIPALITY OF LOON, PROVINCE OF BOHOL AND IMPOSING FEES AND PENALTIES THEREON-

Be it ordained by the 11th Sangguniang Bayan of Loon, Bohol in session duly assembled:

Section 1. QUALIFIED BUYERS.

- a.) Only Loonanon businessmen are qualified and allowed to engage in the business of buying scrap iron, plastics and related used/ reusable items in any barangay of this municipality.
- b.) Rationale. The restriction as to territorial qualification of the buyers is intended to ensure safety of the properties of the Loonanon against the danger of the incident of thefts, the unidentified buyers who come from other towns.

Section 2. DAY OF TRANSACTION.

- a.) The day of transaction for the buying of said items shall be exclusive for Saturdays only.
- b.) Rationale. The household members shall be aware of the buyers of said items who shall roam around the barangay for said business.

Section 3. MAYOR'S/BUSINESS PERMIT

- a.) No buyer of scrap iron, plastics and other used items are allowed to transact business in any barangay of this municipality unless an annual Mayor's Permit shall first be secured in accordance with Section 3A.02,(2.17g), of the Revenue Code of Loon, Bohol.
- b.) No business of buying such items are allowed to transact business within the territorial jurisdiction of Loon without having registered their business at the Treasurer's office.
- c.) The treasurer's office shall keep the list of natural or juridical persons engaging in the business of buying said items and shall furnish copies of qualified buyers to all barangay captains to be posted at the barangay halls for identification.
- d.) Buyers of said items must be ready to present to any police personnel, citizen or barangay official the Mayor's Permit as proof that they are doing legitimate business therein.

Section 4. BUSINESS BARANGAY CLEARANCE

- a.) Pursuant to Section 152 c of RA 7160, no Mayor's Permit unless a barangay clearance is first secured.
- b.) No person shall engage in the business of buying scrap iron, plastics and other reusable materials in the barangay unless a Mayor's Permit has secured, and upon payment of annual Barangay Business Clearance amounting to Fifty Pesos (P50.00) from the barangay to which the business of buying such recyclable materials or scrap iron is operating.
- c.) The names of the buyers of said items must be registered at the barnagy through the barangay secretary for purposes of identity.
- d.) Any person whose name is not enlisted in the barangay list of buyers, even he is an agent or employee of registered buyer, shall be subject for strict verification and police surveillance, until he shall be cleared from any danger of syndicated theft operations, at the pretense of engaging said business.
- e.) In no case shall any day be allowed for the transaction of said business, except Saturdays only 8:00A.M to 5:00P.M.

Section 5. SURVEILLANCE

- a.) The PNP is mandated to conduct surveillance every Saturday and other days for purposes of strictly implementing the provisions if this ordinance.

- b.) The barangay tanods shall conduct daily surveillance especially on Saturday in order to protect the properties of the barangay constituents as against any mode of business that endangers the lives and properties of the barangay constituents

Section 6. **BMRF.**

The aforementioned provisions shall be suspended for barangays having installed a Barangay Material Recovery Facility (BMRF) wherein all recyclable materials including scrap iron shall be deposited therein to the ownership of the barangay, in which case, the buyers of said item shall proceed to the BRMF to transact business every Saturday, instead of roaming around the residents of the barangay.

Section 7. **PENALTY.**

Any violation of this ordinance shall be fined and penalized as follows:

First Offense –P 500.00

Second offense- P 1,000.00

Third Offense and succeeding offense-P2,500.00, confiscation of materials and cancellation of business permit.

Section 8. **EFFECTIVITY CLAUSE.** This ordinance shall take effect immediately upon its approval.
