MUNICIPAL ORDINANCE NO. 12-003 Series of 2012

AN ORDINANCE AMENDING SECTION 5F.02 (4) PARAGRAPHS 1 AND 4 OF MUNICIPAL ORDINANCE NO. 11-007, SERIES OF 2011 OTHERWISE KNOWN AS THE REVENUE CODE OF LOON, BOHOL

Be it ordained by the 11th Sangguniang Bayan of Loon, Bohol in session duly assembled:

- Section 1. **PROVISION**. Section 5F.02 (4) paragraphs 1 and 4 of Municipal Ordinance No. 11-007, series of 2011, otherwise known as the Revenue Code of Loon, Bohol is hereby amended to read:
 - 1) The water rates for residential, commercial, industrial, agricultural, institutional, communal consumption shall be uniform as follows:

1-10 cubic meter	- P8.75 / cm
11-20	- P11.75 / cm
21-30	- P14.75 / cm
31 up	- P17.75 / cm

2) "The aforementioned rates shall automatically be adjusted depending on the consumption of the adjustment of electricity bill per accounting computation through the Loon Waterworks System Billing Section, taking into consideration the actual increase or decrease of electricity rate." Section 2. **REPEALING CLAUSE**. Any provision or rule inconsistent thereto is hereby repealed or modified accordingly.

Section 3. **EFFECTIVITY**. This ordinance shall take effect immediately upon its approval and upon posting in at least 3 conspicuous places of the municipality.
