AN ORDINANCE AMENDING SECTION 22 (b) OF MUNICIPAL ORDINANCE NO. C-001, SERIES OF 2004, ENTITLED, "AN ORDINANCE CODIFYING THE GENERAL AND ADMINISTRATIVE ORDINANCES OF THE MUNICIPALITY OF LOON, BOHOL"

BE IT ENACTED by the 12th Sangguniang Bayan of Loon, Bohol in session duly assembled:

Section 1. AMENDATORY PROVISION. Section 22 (b) of Municipal Ordinance No. C-001 is hereby amended to read, as follows:

- b1) The regular session of the Sangguniang Bayan shall be held every Friday at 9:00 o'clock in the morning at Hon. Juan M. Relampagos Session Hall. In case of a Friday falling on a holiday, the day preceding such holiday/s shall be the session day for the week. When public interest so demands, special sessions may be called by the Honorable Mayor, the Presiding Officer, or by a majority of the members of the Sanggunian.
- b2) It shall also be held at the barangay hall during the scheduled District Consultation Conference once every two months with the barangay officials of the district, in coordination with the Office of the Mayor for a joint Executive-Legislative District Consultation.

Section 2. REPEALING CLAUSE. Section 22 (b) of Municipal Ordinance No. C-001, Series of 2004 is hereby repealed/ modified accordingly.

Section 3. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.


