MUNICIPAL ORDINANCE NO. 17-005

Series of 2017

AN ORDINANCE REGULATING THE OPERATION AND MANAGEMENT OF THE TUBIG LOON SPRING PARK AS A PUBLIC AMUSEMENT PARK AND ECONOMIC ENTERPRISE OF THE LOCAL GOVERNMENT UNIT OF LOON, PROVINCE OF BOHOL

Be it ordained by the 13th Sangguniang Bayan of Loon, Bohol in session duly assembled:

Section 1. Description of the Site. The Tubig Loon Spring Park shall have the following components:

- 1.a. Reception area, multipurpose hall, sundry shop/souvenir shop, toilets and other utility areas;
- 1.b. Leisure and amusement area composed of, but not limited to pools, slides, shower area, play area, picnic sheds and huts, multipurpose stage, and others;
- 1.c. Heritage area composed of a cliff, a spring inside a cave, and the main reservoir; and
- 1.d. Facilities for swimming competitions and training.

Section 2. Management, Operation and Maintenance.

2.a. The Tubig-Loon Spring Park shall be established as an economic enterprise under the Office of the Mayor.

2.b. The appropriate government agencies or departments shall be consulted on specific issues, concerns or requirements in regard to the development, establishment and operation of the Tubig-Loon Spring Park.

2.c. As a government facility, the park shall subject all its financial transactions to the standard operating procedures adopted by the Local Government Unit. The income or proceeds that the park generates shall accrue to the general fund of the LGU.

2.d. The Office of the Mayor shall organize a properly selected personnel and staff for the Tubig Loon Spring Park. They shall include, but not limited to, a manager, utility workers,

lifeguards, security guards, and others. They shall perform specific duties and responsibilities that are necessary for effecting a smooth operation of the park, and their services compensated based on rates allowed by law.

2.e. The personnel and staff of the Tubig-Loon Spring Park shall follow ethical standards at work. They shall enjoy benefits and other incentives depending on availability of funds. They will be encouraged to undergo training to improve their skills and capabilities.

2. f. The amusement facility shall open at 6:00 in the morning and close at 6:00 in the evening. It shall, however, disallow admission of new arrivals at 5:00 in the afternoon, except on special occasions approved by the Mayor.

2.g. Meeting and conferences, programs and events, parties or celebrations, and similar activities shall be allowed within the park provided that these do not interfere with the activities for which the place has been established.

2.h. Guidelines in the use of the amenities within the Tubig-Loon Spring Park shall be issued through an executive order. These shall include, but not limited to, personal conduct of visitors, safety and security, and waste management.

2.i. The Municipal Tourism Council shall serve as the Tubig-Loon Spring Park Management Council.

Section 3. Entrance and Rental Fees, Donations and Other Revenues.

3.a. The general admission fee to the amusement park shall be Twenty Five Pesos (P 25.00) and Fifteen Pesos (P 15.00) for adults and children below 12 years old, respectively, regardless of the number of hours spent thereat, and regardless of whether the visitor uses the water amenities or not. Children who are below three years old are free of charge.

3.b. The general admission fee shall be inclusive of the use of the pools, shower rooms, play area, and toilets.

3.c. Special events like private programs and gatherings, as well as swimming competitions shall be charged a rental fee of One Thousand Pesos (P 1,000.00) per event for the first hour and Five Hundred Pesos (P 500.00) for the next hour or a portion thereof, and so on. This does not include the general admission fee per person and rental fee per picnic shed or hut.

3.d. Persons using the park as venue for artistic or creative pursuits like photography, film, painting and others shall be charged the general admission fee.

3.e. Rental for the picnic sheds or huts shall be Five Hundred Pesos (P 500.00) per day or portion thereof. This does not include the general admission fee per person.

3.f. The sundry/souvenir shop shall accept items for sale on consignment, particularly from producers of local handicrafts and delicacies, provided that a ten-percent (10%) mark-up on the price of every product or item sold shall go to the coffers of the Local Government Unit.

3.g. Rentals for amenities and services that may be installed or available in the future shall be determined in a special ordinance.

Section 4. Monitoring and Evaluation. The Local Government Unit, through its concerned departments and offices, shall regularly assess the facilities of the Tubig-Loon Spring Park, monitor its overall performance as an economic enterprise, and recommend courses of action for its maintenance and further development.

Section 5. Risks and Injuries. The persons or swimmers shall bear personal liability to whatever damage or injury, unless it is proven that its cause is exclusively due to defective structure or installations or technical defect in the area.

In addition thereto, the Pool Rules promulgated by the Mayor in an executive order shall be posted within the area of Tubig-Loon Park.

Section 6. Drinking and Smoking Area. There shall be designated as “drinking and smoking area” of the Park. In no case shall anybody take alcoholic drinks and/or smoke at the pool and bathing areas.

Section 7. First Aid Clinic and Rescue Team. There shall be established First Aid and Rescue Clinic to be composed of Health Personnel and Lifeguards, in coordination with Alagad Center.

Section 8. Repealing Clause. Any existing ordinance that is inconsistent with the provisions of this ordinance is hereby repealed or modified accordingly.

Section 9. Effectivity Clause. This ordinance shall take effect immediately upon approval and posting in strategic places within the Municipality of Loon, and publication in the provincial newspaper of general circulation in three consecutive weeks pursuant to Section 188 of RA 7160.


Section 8. Repealing Clause. Any existing ordinance that is inconsistent with the provisions of this ordinance is hereby repealed or modified accordingly.


