MUNICIPAL ORDINANCE NO. 18-003 Series of 2018

AN ORDINANCE RECOGNIZING AND GRANTING BENEFITS TO QUALIFIED LOONANON SENIOR CITIZENS WHO REACHED THE AGE OF 90 YEARS OLD RESIDING IN THE MUNICIPALITY OF LOON, BOHOL

Be it enacted by the 13<sup>th</sup> Sangguniang Bayan of Loon, Bohol in session duly assembled:

**SECTION 1. POLICY** – It is the policy of this LGU to be grateful to the Senior Citizens who in one way or another have contributed much for the socio-economic progress of the Loonanon community.

**SECTION 2. 90<sup>TH</sup> BIRTHDAY** – Upon reaching the age of ninety (90) years old, the concerned senior citizen who is actually residing in the Municipality of Loon shall be awarded with a Plaque of Recognition duly signed by the Municipal Mayor, Municipal Senior Citizens Federation President and the Punong Barangay to which the honoree is a resident. A cash gift of a minimum amount of P5,000.00 and a maximum of P10,000.00 shall be given to the honoree on his/her 90<sup>th</sup> birthday.

**SECTION 3. 2018 RECOGNITION** – On the first year of implementing this ordinance, all senior citizens who reached the age of more than 90 years old shall be simultaneously awarded with corresponding cash awards of a minimum amount of P5,000.00 to a maximum amount of P10,000.00 during the culmination of the Senior Citizens Week Celebration assisted by the concerned Punong Barangays and MSWDO personnel.

**SECTION 4. FUNDING** – The Technical Working Group (TWG) shall source out funds for the awards and cash gift from the annual budget of the LGU.

**SECTION 5. SEARCH AND EVALUATION TECHNICAL WORKING GROUP (TWG)** – There shall be created Search and Evaluation Technical Working Group (TWG) composed of the following:

**SECTION 8. REPEALING CLAUSE** – Any ordinance, rule or executive order and regulations in conflict with the provisions of this ordinance is hereby repealed or modified accordingly.

**SECTION 9. EFFECTIVITY** – This ordinance shall take effect immediately upon its approval and due publication in newspaper of general circulation, subject to the availability of funds and/or the passage of an appropriation ordinance to that effect.
