AN ORDINANCE AMENDING SECTION 1 OF MUNICIPAL ORDINANCE NO. 04-006, SERIES OF 2004, ENTITLED: “AN ORDINANCE CREATING THE EIGHT (8) ADMINISTRATIVE DISTRICTS OF THE MUNICIPALITY OF LOON UNDER THE SUPERVISION OF THE EIGHT REGULAR MEMBERS OF THE SANGGUNIANG BAYAN AND PROVIDING ITS ORGANIZATION SET-UP THEREOF”

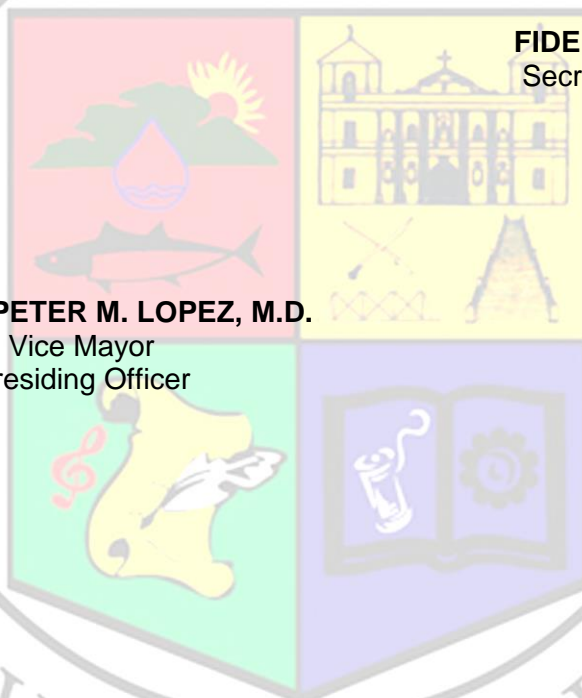
