**AN ORDINANCE AMENDING SECTION 123 PARAGRAPH B AND SECTION 126 OF MUNICIPAL ORDINANCE NO. C-001 SERIES OF 2004, ENTITLED: “AN ORDINANCE CODIFYING THE GENERAL AND ADMINISTRATIVE ORDINANCES OF THE MUNICIPALITY OF LOON, BOHOL”**

Be it ordained by the 13<sup>th</sup> Sangguniang Bayan of Loon, Bohol on session duly assembled:

**Section 1.** SECTION 123 of Municipal Ordinance No. C-001 Series of 2004 shall be amended to read:

“The Mahjong permits shall be limited to the following hours of play: 9:00 o’clock in the morning until 10:00 o’clock in the evening during weekdays from Monday to Friday. This provision is not applicable during weekends, official holidays and wakes.”

**Section 2.** SECTION 126 of Municipal Ordinance No. C-001 Series of 2004 shall be amended by inserting the following line to read:

“Minors under 18 years old shall not be allowed to participate either as direct participant or as audience thereon.”

**Section 3.** REPEALING CLAUSE. Section 123 “B” and Section 126 of Municipal Ordinance No. C-001 Series of 2004 are hereby repealed or modified accordingly.

**Section 4.** EFFECTIVITY. This ordinance shall take effect after its approval.

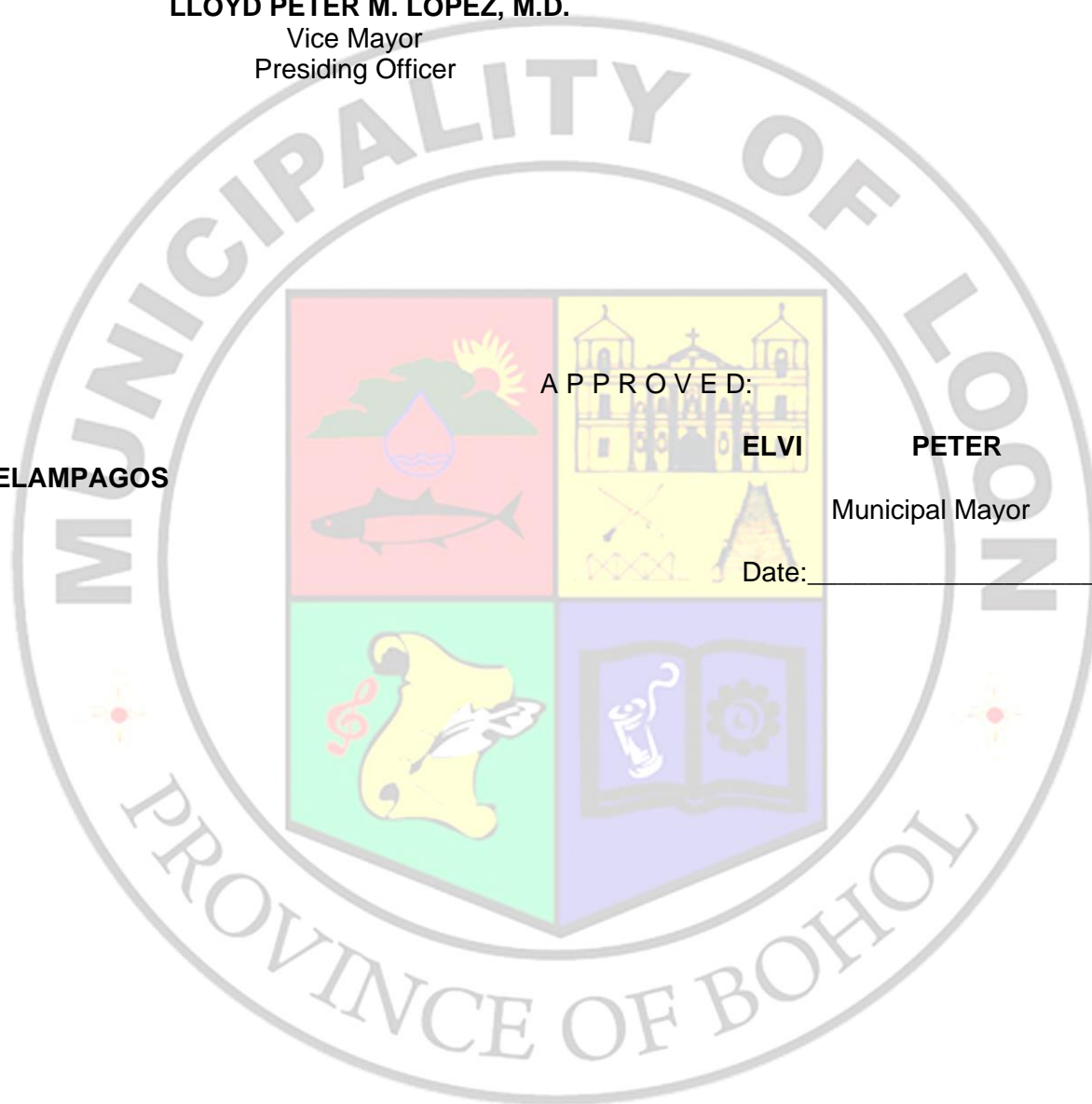


