**MUNICIPAL ORDINANCE NO. 19-001**  
Series of 2019

**AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 02-002 SERIES OF 2002, ENTITLED: "AN ORDINANCE REGULATING THE OPERATION OF INTERNET CAFÉ IN THE MUNICIPALITY OF LOON, BOHOL"**

Be it ordained by the 13<sup>th</sup> Sangguniang Bayan of Loon, Bohol on session duly assembled:

**SECTION 1.** Section 2 of Municipal Ordinance No. 02-002 Series of 2002 shall be amended to read:

- A) Business hours of operation for internet cafes shall be from 6:00 AM to 8:00 PM for minors and 6:00 AM to 10:00 PM for adults.
- B) Elementary and High School Students are not allowed to enter the internet café during school days (Monday to Friday) and during Saturday special classes from 6:00 AM to 5:00 PM and 6:00 AM to 7:00 PM for Senior High Schools except those who are required to do research work or school-related work with a permit coming from the School Head/ adviser-teacher stating the authority to do internet research.

**SECTION 2. PROHIBITED ACTS.** The following are the prohibited acts:

1. Viewing of any pornographic video or photos.
2. Failure of the business establishment to close their internet café after 10:00PM.
3. Failure of the business establishment to release the customers after the closure time for minors at 8:00PM, and adults at 10:00PM.
4. Failure of the business establishment to maintain a logbook of names and age of users, for minors and adults.
5. Failure of the business establishment to comply the mandatory posting requirement.

**SECTION 3. MANDATORY POSTING.** The following phrases shall be visibly posted at the internet café, to read:

“Internet Operation Hours:

- a) MINORS - 6:00AM to 8:00PM; ADULTS - 6:00M-10:00PM”
- b) Students - not allowed to enter internet café during school days from 6:00AM-5:00PM
- c) Viewing of pornographic videos or photos is prohibited

**SECTION 4.** Section 3 of the Municipal Ordinance No. 02-002 Series of 2002 shall be amended to read:

The registered owner or operator shall be held jointly liable with the attendant or watcher for whatever violation of this ordinance.

**SECTION 5. PENALTY.** Section 5 of the Municipal Ordinance No. 02-002 series of 2002 shall be amended to read:

The owner/operator and the watcher of internet café shall be held liable for any violation, on per day basis, as follows:

- A. First Offense - P 500.00
- B. Second Offense - P 750.00
- C. Third Offense - P 1,000.00
- D. Succeeding Offenses - cancellation/revocation of business permit

**SECTION 6. REPEALING CLAUSE.** Municipal Ordinance No. 02-002 Series of 2002 is hereby repealed or modified accordingly.

**SECTION 7. EFFECTIVITY.** This ordinance shall take effect immediately upon its approval and due publication in a newspaper of general circulation.


