**MUNICIPAL ORDINANCE NO. 19-002**  
Series of 2019

**AN ORDINANCE AMENDING SECTION 6.1 OF THE MUNICIPAL ORDINANCE NO. 17-009 SERIES OF 2017, ENTITLED: "AN ORDINANCE REGULATING THE OPERATION, MANAGEMENT AND DEVELOPMENT OF LOON PUBLIC MARKETS OF THE MUNICIPALITY OF LOON"**

Be it ordained by the 13<sup>th</sup> Sangguniang Bayan of Loon, Bohol in session duly assembled:

**SECTION 1.** Section 6.1 of the Municipal Ordinance No. 17-009 Series of 2017 shall be amended to read:

**6.1 MARKET 1: Loon Town Square.**

There shall be established a commercial and business activity center named "Loon Town Square" otherwise known as LTS at the site of the old Loon Public Market in Moto Norte, Loon, Bohol. This shall be divided into the following sections: (*Annex-A*)

**A. Sectioning:**

**1. South Wing**

**A. Franchised Fastfood Chain outlet.** There shall be provided a space for franchised fastfood chain outlet at the South Wing Section- A of the LTS with a minimum area of 16 square meters. More than one block can be consolidated or joined together depending on the need of the lessee.

**B. Mart.** There shall be an opening for a modern and air-conditioned mart where frozen or refrigerated food products like fish, meat, fruits, vegetables and other non-refrigerated specially-packaged food and beverages or drinks will be offered and sold to the public located at the South Wing Section-B of Loon Town Square. The blocks 8,9,10,11,12,13 and 14 of the South Wing-B shall be fused into one (1) unit with a total floor area of 112 square meters in order to house the said mart.

**2. North Wing.** This section shall be leased to any of the following business establishments:

- a) Loon's Best Products Display Center
- b) Cargo Forwarders/Couriers
- c) Ticketing and Tour Services
- d) Coffee shops & Refreshment Parlors
- e) Pawnshops and Money Changers, Money Remittance Centers and Payment Centers
- f) Banks & Lending Institutions
- g) Cellphone, Gadget, Electronics Repair Shops
- h) Computer Supplies and other IT Equipment
- i) CCTV and other Electronics
- j) Appliance Centers
- k) Motorcycles and Parts Display
- l) Flower Shops
- m) Internet shops and cafes

**B. Right to Occupy and Rental Rate:**

The compliance on this provision shall be monitored by the Market Council through the Market Administrator.

**SECTION 2. REPEALING CLAUSE.** Any ordinance inconsistent thereto is hereby repealed or modified accordingly.

**SECTION 3. EFFECTIVITY.** This ordinance shall take effect upon its approval and due publication in a newspaper of general circulation in (3) consecutive weeks pursuant to Section 188 of RA 7160.

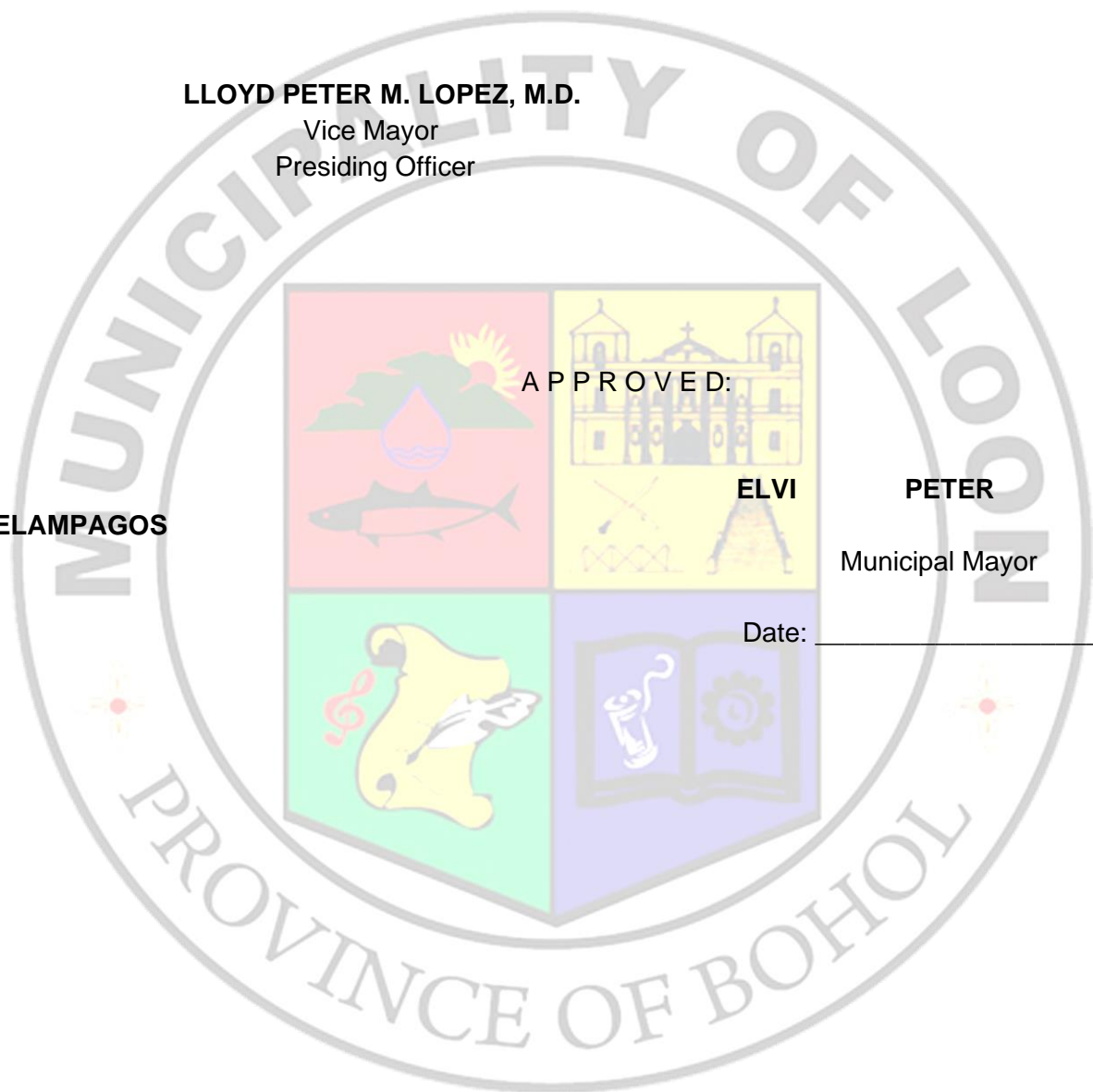



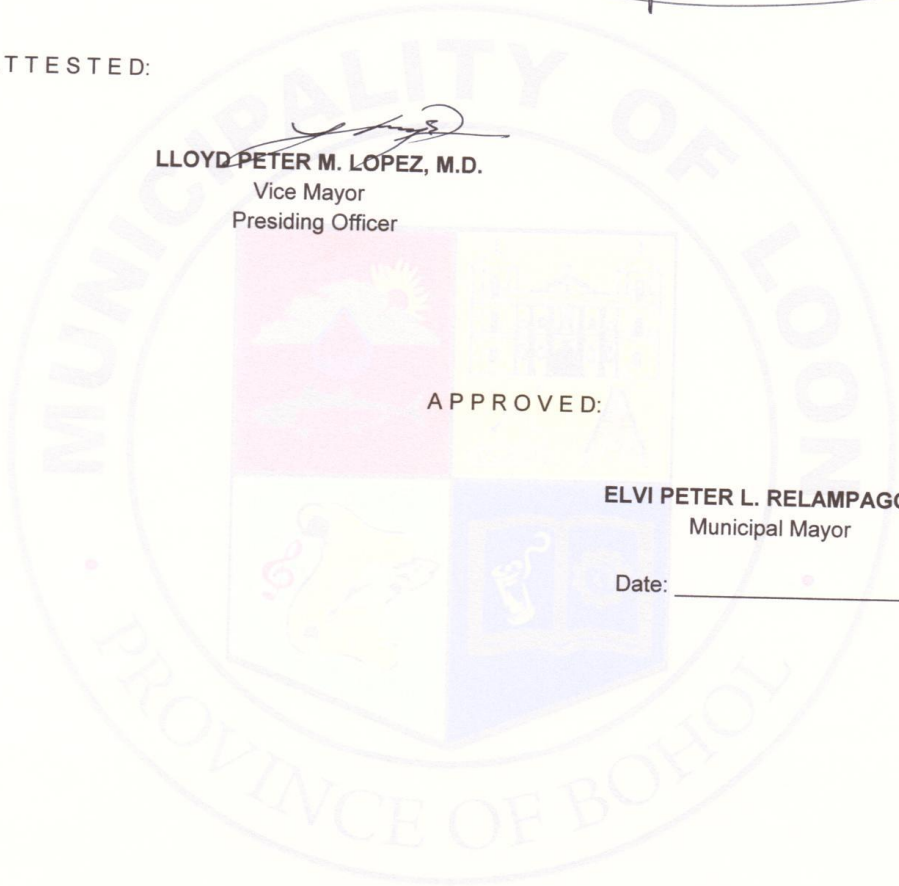
