**MUNICIPAL ORDINANCE NO. 20-007**  
Series of 2020

**AN ORDINANCE AMENDING SECTION 8 OF MUNICIPAL ORDINANCE NO. 17-009, SERIES OF 2017, ENTITLED: "AN ORDINANCE REGULATING THE OPERATION, MANAGEMENT AND DEVELOPMENT OF LOON PUBLIC MARKETS"**

Be it enacted by the 14<sup>th</sup> Sangguniang Bayan of Loon, Bohol in session duly assembled:

**SECTION 1.** Section 8 of Municipal ordinance No. 17-009, Series of 2017 is hereby amended to read:

*Section 8. Food Preparation and Cooking Area. a) There shall be designated areas for food preparation and cooking outside the public market with usage fee of P500.00/ month with an area of 6 square meters (2x3 meters) and b) Bakery, coffee shop and restaurant operators shall be allowed to use electric stoves/ microwave ovens and other types of electric cooking equipment inside the public market building, Provided, that they secure approval and clearance from the Bureau of Fire Protection for safety and precautionary measures.*

**SECTION 2. REPEALING CLAUSE.** Section 8 of Municipal Ordinance No. 17-009, Series of 2017 is hereby amended or modified accordingly.

**SECTION 3. EFFECTIVITY.** This ordinance shall take effect upon its approval.

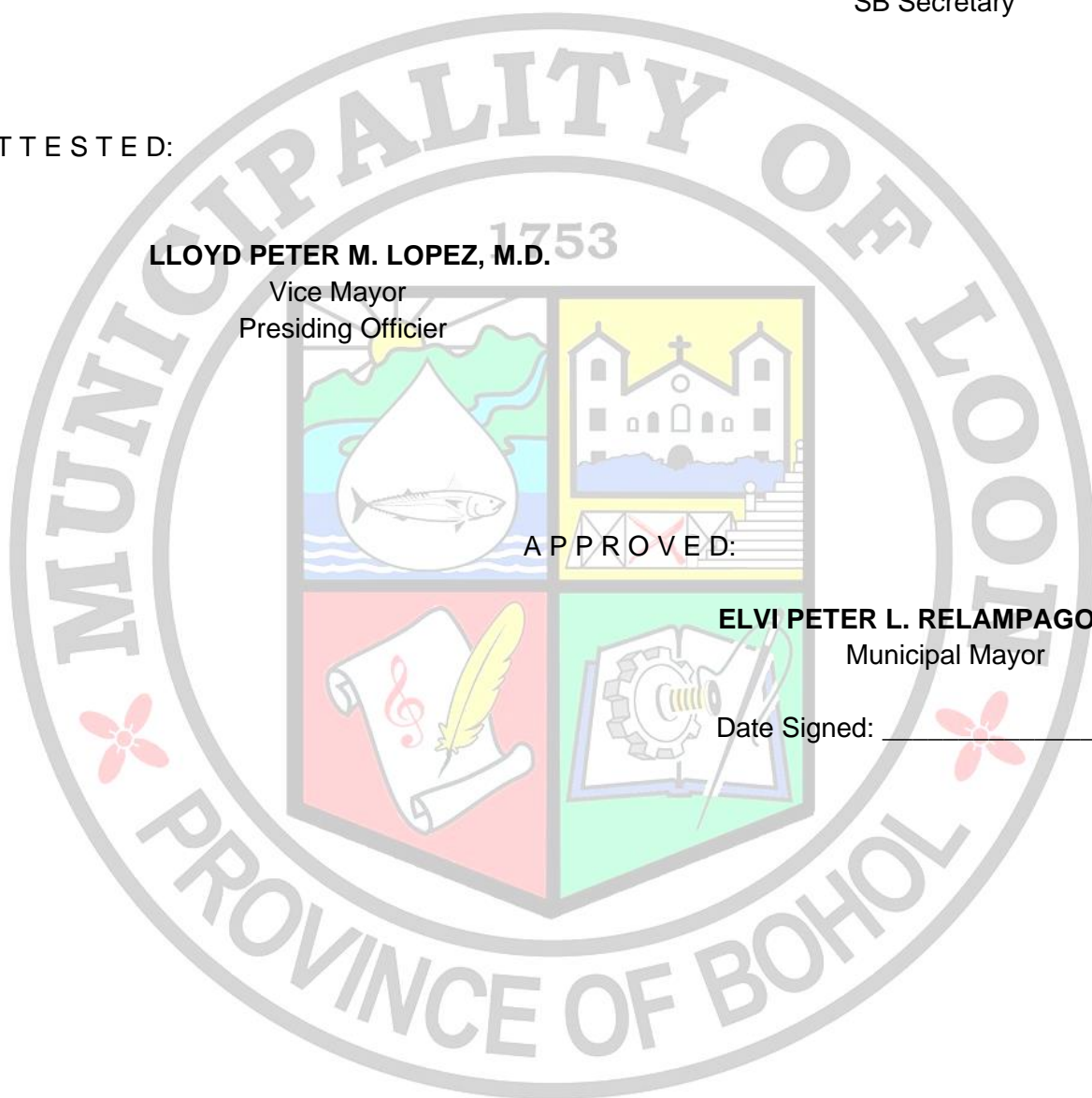
