Be it ordained by the 14th Sangguniang Bayan of Loon, Bohol on session duly assembled:

PURPOSE MUNICIPAL ORDINANCE NO. 14-003, SERIES OF 2014"

SECTION 1. Section 12a of Municipal Ordinance No. 20-002, Series of 2020 shall be amended to read:

SECTION 12. PROHIBITED ACTS. The following acts are strictly prohibited on the uplifted intertidal zone:

12a. Construction or installation of hazardous and/ or pollutant industrial facilities, such as petroleum oil depot, refilling or storage station or facility for any form of hazardous and/ or flammable substances such as but not limited to petroleum products namely gasoline, diesel, kerosene, liquefied petroleum gas (LPG), methane, propane, butane, octane and/ or other similar substances, products with foul odor, warehouse for storage of pollutant substances and/ or highly explosive substances, high voltage electric, commercial scale piggery, poultry,

embalming industry or other similar industrial facilities within the uplifted intertidal zone and extending up to 250 meters from its peripheral margin; any structures like multipurpose sheds and buildings, residential houses, and others that are not part of the development master plan for the area;

SECTION 2. REPEALING CLAUSE. Any provision of any existing ordinance inconsistent thereto shall be deemed repealed or modified accordingly.

SECTION 3. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
