AN ORDINANCE AMENDING SECTION 6 NO. 16 "CELLSITES", ARTICLE IX OF MUNICIPAL ORDINANCE NO. 07-002 SERIES OF 2007, ENTITLED: "THE ZONING CODE OF THE MUNICIPALITY OF LOON"

Be it ordained by the 14<sup>h</sup> Sangguniang Bayan of Loon, Bohol on session duly assembled:

**SECTION 1.** Section 6 No. 16 "Cellsites", Article IX of Municipal Ordinance No. 07-002, Series of 2007 shall be amended to read:


**SECTION 6.** Special Use Permit. Uses or structures that require the issuance of Special Use Permits before they maybe permitted are those which:

16. Cellsites. Shall be located in rural areas, provided, the same shall be constructed in area not less than Fifty (50) meters away from any residential building; provided further; that a public hearing is conducted in the barangay where the cellsite is proposed to be located and provided finally, that existing cellsites shall not be impaired.

**SECTION 2. REPEALING CLAUSE.** Any provision of any existing ordinance inconsistent thereto shall be deemed repealed or modified accordingly.
