**MUNICIPAL ORDINANCE NO. 21-013**

**AN ORDINANCE UPGRADING THE SALARY GRADE OF NURSE II PLANTILLA POSITIONS FROM SALARY GRADE 15 TO SALARY GRADE 16 PURSUANT TO DBM CIRCULAR NO. 2021-2 (MODIFICATION OF NURSE POSITIONS)**

### RATIONALE

The Department of Budget and Management (DBM) issued Circular No. 2021-2 dated August 25, 2021 the subject of which is Modification of Nurse Positions. Hence, it is imperative for the Local Government Unit to increase the salary, allowances and other benefits for the said adjustment which shall be supplemented to the budget for the month of December, FY 2021 and years hereafter.

Be it enacted by the 14<sup>th</sup> Sangguniang Bayan of Loon, Bohol in session duly assembled that:

**SECTION 1. SHORT TITLE.** This ordinance shall be entitled as “An Ordinance Upgrading the Salary Grade Of Nurse II Plantilla Positions From Salary Grade 15 to Salary 16 Pursuant To DBM Circular No. 2021-2 (Modification Of Nurse Positions)”.

**SECTION 2. STATEMENT OF POLICY.** The main purpose of DBM Circular No. 2021-2 (Modification of Nurse Positions) is to prescribe the rules and regulations on the upgrading of the previous Nurse II positions by one (1) SG, as well as to provide the administrative processes for the retention of the position titles of nurses with their corresponding SG assignments.

**SECTION 3. UPGRADE OF SALARY GRADE.** The Nurse II plantilla positions with Salary Grade 15 shall be adjusted to Salary Grade 16 and shall be charged exclusively to the funds of the Local Government Unit of Loon, subject to the Personnel Schedule limitation in LGU budgets pursuant to Sections 325 (a) and 331 (b) of Republic Act No. 7160.

**SECTION 4. ADJUSTMENT OF SALARY GRADE.** The amount required to implement the upgrade of salary including increase in allowances and other benefits for the said adjustments shall be added for the month of December, FY 2021 and years hereafter.

**SECTION 5. REPEALING CLAUSE.** All other ordinances, rules and regulations, or parts thereof, which are in conflict with, or contrary to, the provisions of this ordinance are hereby repealed, amended or modified accordingly.

**SECTION 6. EFFECTIVITY CLAUSE.** This ordinance shall take effect upon its approval.


