MUNICIPAL ORDINANCE NO. 22-010 Series of 2022

AN ORDINANCE AMENDING SECTIONS 1, 2.A, 2.F, 2.I AND SECTIONS 3.A, 3.C, 3.E, 3.F, OF MUNICIPAL ORDINANCE NO. 17-005, SERIES OF 2017 ENTITLED "AN ORDINANCE REGULATING THE OPERATION AND MANAGEMENT OF THE TUBIG LOON SPRING PARK AS A PUBLIC AMUSEMENT PARK OF THE LOCAL GOVERNMENT UNIT OF LOON, **PROVINCE OF BOHOL**"

Be it enacted by the 15th Sangguniang Bayan of Loon, Bohol in session duly assembled:

SECTION 1. Section 1 shall be amended by adding:

- "1.a. There shall be a parking area to be designated by the Municipal Traffic Management Office (MTMO) with the corresponding fees as follows:
 - i. Motorcycle – P10.00
 - Tricycle P15.00 ii.
 - Four-wheeled and above vehicle P30.00 iii.

2.a. The Tubig-Loon Spring Park shall be established as an economic enterprise under the Office of the Mayor as soon as it becomes economically and technically feasible."

SECTION 2. Section 2.f. of Municipal Ordinance No. 17-005, Series of 2017 shall be amended to read:

"The amusement facility shall open at 5:30 in the morning and close at 6:00 in the evening, daily except during repair and maintenance schedule. It shall, however, disallow admission of new arrivals at 5:00 in the afternoon, except on special occasions approved by the Mayor."

SECTION 3. Section 2.i of Municipal Ordinance No. 17-005, Series of 2017 shall be amended to read:

"The Municipal Tourism Council shall serve as the Tubig-Loon Spring Park recommendatory and implementing body."

SECTION 4. Section 3.a of Municipal Ordinance No. 17-005, Series of 2017 shall be amended to read:

"The general admission fee to the amusement park shall be Eighty Pesos (P80.00) for adults (12 years old and above) and Fifty Pesos (P50.00) for children (4 to 11 years old), regardless of the number of hours spent thereat, and regardless of whether the visitor uses the water amenities or not. Children who are three years old and below are free of charge. The registered Loonanon senior citizen and person with disability (PWD) shall be granted free admission to the Tubig Loon Spring Park during the celebration of his or her actual birthday."

SECTION 5. The phrase "as well as swimming competitions" in the first sentence of Section 3.c of Municipal ordinance No. 17-005, Series of 2017 shall be deleted and therefore the content shall be changed to read:

"Special events like exclusive private programs and gatherings, shall be charged a rental fee of One Thousand Pesos (P1,000.00) per event for the first hour and Five Hundred Pesos (P500.00) for the next hour or a portion thereof, and so on. This does not include the general admission fee per person. The rental fee per picnic shed or hut, table, pool umbrella and chairs shall be Fifty percent (50%) less."

SECTION 6. Section 3.e of Municipal Ordinance No. 17-005, Series of 2017 shall be amended to read:

"Rental for the picnic sheds or huts shall be Three Hundred Pesos (P300.00) with five (5) chairs and one (1) table, Pool Umbrella shall be Two Hundred Pesos (P200.00) with four (4) chairs and one (1) table and Five Pesos (P5.00) fee for every additional chair per day."

SECTION 7. Section 3.f. of Municipal Ordinance No. 17-005, Series of 2017 shall be amended to read:

"The sundry/souvenirs shop shall accept items for sale. The vendors are required to pay Twenty Pesos (P20.00) per square meter per day as rental fee. Moreover, the first priority on selling of various goods, food and drinks shall be given to the seemingly deprived organizations such as Persons With Disabilities (PWD's), Unemployed Single Moms, and other Women's Group for their opportunity to accumulate income. However, any private business establishment may be allowed upon discretion of the management."

SECTION 8. Training and Competition Pool.

8.1 The Training and Competition Pool shall be exclusively used for training only. Swimming trainers or coaches and athletes are the ones allowed to use such pool. The management shall be the one to identify the safety measures and other guidelines or protocols in using the training pool. Swimming athletes duly recognized by the Local Government Unit shall be

privileged for a free admission during the training period. Winners of swimming competition sanctioned by the LGU shall be free of admission for the whole year. An approved certification or ID shall be presented upon entry to the facility.


8.2 Fee for usage of the training and competition pool:

8.2.a. Privately sponsored competition – P5,000.00 per day with free admission for the competitors, coaches and organizers.

8.2.b. Government but not LGU-Loon sponsored competition – P4,000.00 per day with free admission for the competitors, coaches and organizers.

SECTION 9. REPEALING CLAUSE. Sections 1, 2.a, 2.f, 2.i and Sections 3.a, 3.c, 3.e, 3.f, of Municipal Ordinance No. 17-009, Series of 2017 are hereby amended or modified accordingly.

SECTION 10. EFFECTIVITY. This ordinance shall take effect upon its approval.
