AN ORDINANCE AMENDING SECTION 2, NO.15 OF MUNICIPAL ORDINANCE 22-002, SERIES OF 2022, ON QUALIFICATIONS, FUNCTIONS AND RESPONSIBILITIES OF MUNICIPAL GOVERNMENT ASSISTANT DEPARTMENT HEAD 1 (MHO-RHU2), PLANTILLA POSITION OF LOCAL GOVERNMENT UNIT OF LOON, PROVINCE OF BOHOL

Be it enacted by the 15th Sangguniang Bayan of Loon, Bohol in session duly assembled that:

SECTION 1. TITLE. This ordinance shall be known as "An Ordinance Amending Section 2, No. 15 of Municipal Ordinance 22-002, Series of 2022, on Qualifications, Functions and Responsibilities of Municipal Government Assistant Department Head 1 (MHO-RHU2), Plantilla Position of Local Government Unit of Loon, Province of Bohol".

SECTION 2. AMENDMENTS. Section 2, No. 15 of Municipal Ordinance No. 22-002, series of 2022 is hereby amended to read as follows:

Qualifications:


- 1. Education: Doctor of Medicine
- 2. Experience: 3 years experience as medical practitioner
- 3. Training: None
- 4. Eligibility: RA 1080 (Medical Doctor)
