MUNICIPAL ORDINANCE NO. 22-014 Series of 2022

AN ORDINANCE AMENDING SECTION 2 PARAGRAPH 2.1 AND SECTION 3.A. OF MUNICIPAL ORDINANCE 22-005, SERIES OF 2022 AND SECTIONS 1, 2 UNDER NO. 2, OF MUNICIPAL ORDINANCE 22-002, SERIES OF 2022 ON THE CREATION AND MANAGEMENT OF LDRRMO IN THE MUNICIPALITY OF LOON, PROVINCE OF BOHOL

Be it enacted by the 15th Sangguniang Bayan of Loon, Bohol in session duly assembled that:

SECTION 1. TITLE. This ordinance shall be known as “An Ordinance Amending Section 2, Paragraph 2.1 and Section 3.A. of Municipal Ordinance 22-005, Series of 2022 and Section 1, 2 under no. 2 of Municipal Ordinance 22-002, Series of 2022 on the Creation and Management of LDRRMO in the Municipality of Loon, Province of Bohol.

SECTION 2. AMENDMENTS.

2.1. Section 2 Paragraph 2.1 and Section 3.A. of Municipal Ordinance No.22-005, Series of 2022 shall be amended to read as follows:

- a) Section 2.1. CREATION. There shall be created an office to be known as Local Disaster Risk Reduction Management Office in the Municipality of Loon under the Office of the Mayor.
- b) Section 3.A. MANAGEMENT. Municipal Government Assistant Department Head I (LDRRMO) (SG 22).

2.2. Section 1 and Section 2, under No. 2 of Municipal Ordinance No. 22-002, Series of 2022 shall be amended to read as follows:

a) Section 1. CREATION OF PLANTILLA POSITIONS:

Positions	Salary Grade	Office
Municipal Government Assistant Department Head I (LDRRMO)	22	Mayor's Office

b) Section 2. QUALIFICATIONS, FUNCTIONS AND RESPONSIBILITIES.

2. Municipal Government Assistant Head I (LDRRMO) (SG 22) – MDDRMO

Qualifications:

1. Education: Bachelor's Degree
2. Experience: 3 years experience of relevant experience on DRRM
3. Training: 16 hours of relevant training on DRRM
4. Eligibility: Career Service Professional/2nd Level Eligibility

SECTION 3. RATIONALE. The amendments of Section 2, Paragraph 2.1 and Section 3.A. of Municipal Ordinance No.22-005, Series of 2022 and Sections 1 and 2 under no. 2 of Municipal Ordinance 22-002, Series of 2022 are pursuant to Joint Memorandum Circular No. 2014-1 of NDRRMC/DILG/DBM and CSC.

SECTION 4. REPEALING CLAUSE. Section 2 Paragraph 2.1 and Section 3.A. of Municipal Ordinance No. 22-005, Series of 2022, and Sections 1 and 2 under no. 2 of Municipal Ordinance 22-002, Series of 2022 are hereby amended and modified accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect upon its approval and compliance of the necessary requirements set by law.
