MUNICIPAL ORDINANCE NO. 23-005

AN ORDINANCE AMENDING SECTION 13, NO. 2 OF MUNICIPAL ORDINANCE NO. 21-002, SERIES OF 2021, ENTITLED: "AN ORDINANCE ESTABLISHING A MANPOWER DEVELOPMENT CENTER IN THE MUNICIPALITY OF LOON, PROVINCE OF BOHOL, TO BE KNOWN AS THE LOON MANPOWER DEVELOPMENT (LMDC)

Be it enacted by the 15th Sangguniang Bayan of Loon, Bohol in session duly assembled:

SECTION 1. AMENDATORY PROVISION.

Section 13 of Municipal Ordinance No. 21-002, Series of 2021 shall be amended adding one provision on Training Rates, to read:

SECTION 13. Operational Funds and Training Fees

1. Initial Fund. For the initial operation of the Center, the Local Government Unit, through the Sangguniang Bayan, shall appropriate funds in the amount of at least Two Million Pesos (P2,000,000.00) as seed capital of the Local Government Unit (LGU)-Economic Enterprise.
2. Training Fees. There shall be imposed training fees based on the Technical Education and Skills Development Authority (TESDA) training rates on the following courses, among others:

SECTION 2. REPEALING CLAUSE. Any provision inconsistent thereto is hereby repealed or modified accordingly.

SECTION 3. EFFECTIVITY. This ordinance shall take effect immediately upon its approval and due publication in a newspaper of local circulation for three consecutive days pursuant to Section 188 of RA 7160.
