MUNICIPAL ORDINANCE NO. 04-002

AN ORDINANCE REGULATING THE CLOSURE TIME OF THE OPERATION OF KTV AND KARAOKE BAR WITHIN THE TERRITORIAL JURISDICTION OF LOON, BOHOL, PHILIPPINES -

(Author: Honorable Cesar R. Pedrigal)

Be it ordained by the 8th Sangguniang Bayan of Loon, in its regular session duly assembled:

SECTION 1. The closure time of operation of KTV and Karaoke Bar is hereby set at 11:00 P.M

SECTION 2. Any establishments engaged in KTV and Karaoke open and operating beyond 11:00 in the evening shall be deemed violators.

SECTION 3. The following persons are hereby authorized to enforce this ordinance:

- a) PNP
- b) Barangay Officials
- c) Barangay Tanods

SECTION 4. The implementation of this ordinance is suspended during the following occasions:

- a) December 24
- b) December 25
- c) December 31
- d) January 1
- e) Fiesta Vesper (town or barangay)
- f) Fiesta Night (town or barangay)

SECTION 5. Penalty – Violation of this ordinance shall upon conviction, be punished in the following manner:

- a) 1st offense – warning
- b) 2nd offense – P500.00
- c) 3rd offense and succeeding offense – a fine of P1,000.00 and cancellation of business permit, or imprisonment of 3-5 days, or both fine, cancellation and imprisonment at the discretion of the court.

SECTION 6. Repealing Clause – All ordinances, rules, and regulations which are in conflict with this ordinance are hereby repealed or modified accordingly.

SECTION 7. Effectivity – This ordinance shall take effect upon approval.
