**MUNICIPAL ORDINANCE NO. 04-007**

Series of 2004

**AN ORDINANCE AMENDING SECTION 46 OF MUNICIPAL ORDINANCE NO. 03-006, SERIES OF 2003, ENTITLED: TRAFFIC AND TRANSPORTATION ORDINANCE OF THE MUNICIPALITY OF LOON, BOHOL-**

“WHEREAS, it is sensible to grant the petition for a fare rate increase due to a continuing price increase of fuel, lubricant and spare parts in the market for the maintenance of vehicles for hire;

WHEREFORE, be it ordained by the 9<sup>th</sup> Sangguniang Bayan of Loon, Bohol, in session assemble:

SECTION 1. Section 46 of Municipal Ordinance No. 03-006, series of 2003, is hereby amended to read as follows:

SECTION 1. Herein below provide are the following areas within the municipality shall be considered as within the radial travel scheme where minimum fare rate collected from passenger who ride the motorized tricycle from a point to certain points of destination.

From point of origin, to the area of destination, the following shall be the minimum fare rate per passenger, to wit:

TRICYCLES	FARE	STUDENT, SENIOR CITIZEN AND DISABLED PERSONS
1. For the first two (2) kilometers:	P 5.00	20% discount privilege
2. For each succeeding kilometer or a fraction thereof.	P 0.50	

- a) A copy of the schedule of fare rate shall be displayed conspicuously in the motor cab.
- b) Any passenger who refuses to pay the above-prescribed rates of fare shall be fined twenty Pesos (P 20.00).
- c) Any transient operator who violates the rate above shall be penalized in the amount of One Hundred Pesos (P 100.00).

Section 2. Any ordinance or part thereof which is in conflict or inconsistent with the provisions of this ordinance is deemed repealed or modified accordingly.

Section 3. This ordinance shall take effect upon its approval.

- b) Any passenger who refuses to pay the above-prescribed rates of fare shall be fined Twenty Pesos (P 20.00).
- c) Any transient operator who violates the rate stated shall be penalized in the amount of One Hundred Pesos (P 100.00).

Section 2. Any ordinance or part thereof which is in conflict or inconsistent with the provisions of this ordinance is deemed repealed or modified accordingly.

Section 3. This ordinance shall take effect upon its approval.
