AN ORDINANCE ESTABLISHING A MONTHLY PHYSICAL FITNESS AND BLOOD PRESSURE CHECK-UP FOR MUNICIPAL OFFICIALS AND EMPLOYEES OF THE MUNICIPALITY OF LOON”

Be it enacted by the 9th Sangguniang Bayan of Loon in session duly assembled:

Section 1. Title. This ordinance shall be called “The Physical Fitness Program of the Municipality of Loon.”

Section 2. Coverage.

- a. There shall be a monthly Physical Fitness Program of the Municipality of Loon, which includes Blood Pressure check-up to be conducted by the representatives of RHU-1 and RHU-2.
- b. The program shall be participated by the municipal officials and employees of this Municipality on every first Friday of the month from 3:00-5:00 PM.
- c. The Physical Fitness shall be done with any of the following activities:

Section 3. Effectivity.

This Ordinance shall take effect immediately upon its approval.
