#### MUNICIPAL ORDINANCE NO. 05-011 Series of 2005

# AN ORDINANCE AMENDING SECTION 85 OF THE CODE OF GENERAL AND ADMINISTRATIVE ORDINANCES RELEVANT TO THE OBSERVANCE OF CURFEW HOURS-

Be it ordained by the 9<sup>th</sup> Sangguniang Bayan of Loon, Bohol on session duly assembled:

SECTION 1.Imposing Curfew Hour:

- a) All inhabitants of this municipality of Loon, Bohol are hereby prohibited to roam around or stay outside of their residential places from eleven (11:00) o'clock in the evening to four (4:00) o'clock in the following morning.
- b) At quarter to eleven (11:00) o'clock in the evening a sound of siren coming from the municipal fire truck will be heard in the Municipal Hall and a synchronized ringing of barangay chapel bells or gongs on its jurisdiction for at least thirty (30) seconds inorder to remind the attention of the people in the community for the curfew hours.

SECTION 2. Exemptions, The following are exempted to observe curfew hour:

- a) Farmers, vegetable vendors, fishermen, fish vendors and slaughter house personnel. Subject persons shall be required to secure first a certificate from chief of police of Loon, PNP station or from the barangay captains signifying therein for their exemption of the curfew hours.
- b) Persons attending a scholastic function, commencement exercises, convocation, religious and educational program, vigil benefit shows such as disco, drama, basketball, and or in wholesome and decent assemblage, during political rallies, campaign period, yuletide masses, New Year's Eve, All Souls Day, All Saints Day, Holy Week devotions (Holy Thursday, Good Friday, Black Saturday), nightly program activities during town fiesta and barangay fiesta, and all commuters.

- c) Any person on call in connection with their profession of duty such as doctors, nurses, midwives, priest/pastor, police personnel, barangay tanods, security guards and other which can be clearly justified.
- d) Government officials including the barangay officials who are performing their duties or in the course of the performance of their duties.

Section 3. Implementing Authority:

- a) The Philippine National Police PNP personnel assigned in this Municipality shall be the leading agency in the implementation of the ordinance. In line with this, they are given the authority to promulgate implementing rules and guidelines to carry out effectively the purpose of this ordinance.
- b) All barangay officials, barangay tanods and lupon members are hereby deputized in the implementation of this ordinance.

Section 4. Punishment/Penalties to be imposed:

Any persons violating the provisions of this Municipal Ordinance shall be punished as follows:

- a) First Offense warning. The offender/violator
  - 1. Shall execute a promissory note to the apprehending officer, assuring that he will no longer go out or roam around outside their places after eleven (11:00) o'clock in the evening and before four (4:00) o'clock the following morning.
- b) Second Offense :
  - 1. Shall be fined of Three Hundred Pesos (P 300.00),
  - 2. Minor's parent, guardian or in their absence, a brother/sister exercising parental authority over said minor shall be required to undergo a half-day Parenting Course together with the minor concerned.
- c) Third Offense:
  - 1. Shall be fined of Five Hundred Pesos (P500.00)
- d) Subsequent violations:
  - 1. Shall be fined of One Thousand Pesos (P1, 000.00) and imprisonment of three (3) days to five (5) days or at the discretion of the court.
  - 2. Shall warrant the filling of appropriate charges against the minor's parent, guardian or in their absences, a brother/sister as provided under Presidential Decree No. 603, as amended, and Republic Act 7160 and other pertinent laws.

Section 5. Incentive scheme. There shall be devised an incentive scheme as follows:

- 1. Apprehending Barangay officials including lupon members and tanods are given 30% share of the penalty charged.
- 2. The informant shall be given 10% share of the penalty charged.
- 3. If there is no informant, the 10% shall be added to the apprehending officers concerned.
- 4. It there are more than one barangay apprehending officers, the sharing shall be in pro rata basis.
- 5. The LGU Loon shall have a sharing of 40%, and the barangay with 20% sharing.

Section 6. Repealing Clause:

All ordinances, rules and regulations or part thereof whose provisions are in conflict with, or contrary to the provision of this ordinance are hereby repealed, amended or modified accordingly.

Section 7. Effectivity Clause:

This ordinance shall take effect immediately upon its approval.
