MUNICIPAL ORDINANCE NO. 06-004

Series of 2006

AN ORDINANCE IMPOSING FEES IN THE USE OF "LIQUID CRYSTAL DISPLAY" (LCD) EQUIPMENT, A MULTIMEDIA PROJECTOR OWNED BY THE MUNICIPALITY OF LOON-

Be it ordained by the 9th Sangguniang Bayan of Loon, Bohol in session duly assembled:

Section 1. Rental/Service Fee. There shall be imposed a rental/service fee of Two Hundred Fifty Pesos (P250.00) per usage / per day in the use of "Liquid Crystal Display" (LCD) equipment owned by the municipality.

Section 2. Users. The following are allowed to use the LCD for a fee:

- a) Barangays of Loon
- b) Non-Government Organizations
- c) Educational Institutions
- d) Business sector
- e) Religious sector

Section 3. <u>LCD Management</u>. Any user shall secure a permit from the Office of the Mayor upon favorable endorsement from the Sangguniang Bayan in coordination with the General Services Office and upon due payment from the Municipal Treasurer.

Section 4. Proper Placement. The LCD shall be stored at the Sangguniang Bayan Session Hall. Proper coordination with the said office shall be coursed through for the maintenance of said equipment.

Section 5. <u>LCD Operator</u>. The Sangguniang Bayan shall identify at least 2 authorized operators. Should the service exceeds the office hour, the user is obligated to remunerate for the services of the LCD operator proportionate to his daily salary or wage.

Section 6. <u>Liability</u>. It shall be the responsibility of the user to pay the burden of all the expenses for whatever damage accruing thereto in the use of the LCD.

Section 7. <u>Trust Fund</u>. Any income in the use of the LCD unit shall be deposited in "Trust Fund" for its maintenance.

Section 8. <u>Penalty</u>. Any violation to the above provisions of this ordinance shall be fined:

(1) 1 st offense	– P 500.00
(2) 2 nd offense	– P 1,000.00
(3) 3 rd and succeeding offenses	– P 2,500.00

Section 10. Effectivity. This ordinance shall take effect immediately upon its approval
