MUNICIPAL ORDINANCE NO. 07- 003
Series of 2007

AN ORDINANCE DECLARING THE PIG-OT WESTERN ROAD WHICH TRAVERSES FROM THE MUNICIPAL LOT OCCUPIED BY PIG-OT ELEMENTARY SCHOOL AS MUNICIPAL ROAD -

BE IT ENACTED by the 9th Sangguniang Bayan of Loon, Bohol in session duly assembled:

Section 1. DECLARATION. The road opening project for the first quarter of 2007 located in the western part of barangay Pig-ot through the Congressional fund of Hon. Edgar M. Chatto with a distance of Three Hundred Five (305) meters, which traverses from Lot No.3546 owned by the Municipality of Loon upon which Pig-ot Elementary School is located, shall be declared as "municipal road".

Section 2. RATIONALE. The Local Government Unit (LGU) responsibility of developing LGU lots extends to the rural areas especially when it affects public interest, preferably for educational convenience of its constituents.

Section 3. MAINTENANCE. The Local Government Unit (LGU) of Loon shall maintain for the development of the municipal road.

Section 4. ROAD NAME. The name of the road shall be "VIAJEDOR STREET".

Section 5. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
