MUNICIPAL ORDINANCE NO. 08- 004 Series of 2008

AN ORDINANCE CREATING THE FARMER SCIENTIST TRAINING PROGRAM, ITS IMPLEMENTING GUIDELINES, AND PROVIDING FUNDS FOR THIS PURPOSE -

Be it ordained by the 10th Sangguniang Bayan of Loon in session duly assembled:

Section 1. Title – This ordinance shall be known as "AN ORDINANCE CREATING THE FARMER SCIENTIST TRAINING PROGRAM, ITS IMPLEMENTING GUIDELINES, AND PROVIDING FUNDS FOR THIS PURPOSE"-

Section 2. Objectives of the Farmer Scientist Training Program

2.1. Provide trainings and knowledge to farmers on the techniques, skills, strategies in cropping corn, rice, banana, camote, coconut and potted ornamentals for improved production and other related activities

2.2. Assist farmers in the promotion of their agricultural products to identified markets.

2.3. Create a center of all scientist training efforts of farmers in the Municipality.

2.4. Conduct monthly consultation with farmer scientist organizations and other stakeholders to ensure wide participation in the program.

Section 3. The Farmer Scientist Training Center

3.1. There is hereby created the farmer scientist training center which shall implement the objectives of the FSTP.

3.2. The following is the composition of the administrators of Farmer Scientist Training Center:

Municipal Mayor	- Administrator
Municipal Planning &	
Development Officer	- Co-Administrator
Municipal Agricultural Officer	- Chief Executive Officer
(1) Staff	- MAO personnel
(4) Field workers	- Contractual Workers

3.3. The Farmer Scientist Training Center shall be located at the FITS Center and will be directly under the supervision and control of the Municipal Mayor.

3.4. The Administrators shall promulgate plans and programs in consonance with the objectives herein set-forth on yearly basis, in coordination and after consultation with the Municipal Development Council;

3.5. The Administrators shall directly implement the plans and programs on field and submit an annual report of its accomplishment to the Sangguniang Bayan.

Section 4. Funding Provisions. A yearly appropriation of One Hundred Thousand Pesos (P 100,000.00) shall be allocated in the municipal budget for this purpose.

Section 5. Repealing Clause. Any ordinance inconsistent hereto is hereby repealed or modified accordingly.

Section 6. Effectivity Clause. This ordinance shall take effect immediately upon approval.
