AN ORDINANCE AMENDING SECTION 1 OF MUNICIPAL ORDINANCE NO. 05 – 012, SERIES OF 2005, OTHERWISE KNOWN AS THE TRICYCLE FARE RATE ORDINANCE OF LOON, BOHOL –
