# MUNICIPAL ORDINANCE NO. 08- 013 Series of 2008

## AN ORDINANCE CREATING THE POSITION OF NETWORK CONTROLLER I WITH SALARY GRADE 8 TO BE ASSIGNED AT THE ACCOUNTING OFFICE OF THE MUNICIPALITY OF LOON, BOHOL-

Be it enacted by the 10<sup>th</sup> Sangguniang Bayan of Loon, Bohol in session duly assembled:

- Section 1. **CREATION OF POSITION.** There is hereby created the position of "Network Controller I" with Salary Grade 8 to be assigned at the Accounting Office of the Municipality of Loon, Province of Bohol.
- Section 2. **FUNCTIONS**. The Network Controller I shall perform the following functions:
  - a) Sets up and maintains access privileges and default security levels for eNGAS users, system files of the following databases:
    - 1. Electronic New Government Accounting System (eNGAS) and Budget System of the LGU
    - 2. eNGas system of the 67 Barangays of Loon
    - 3. Electronic Business Permit & Licensing System (EBPLS)

- b) Sets up and maintains access privileges and default security levels for system users, system hardware devices and system files of the following near-term/upcoming computerization projects:
  - 1. Electronic Waterworks System (EWWS) computerized billing and collection
  - 2. Electronic Real Property Tax System (ERPTS)
- c) Responsible for the technical and administrative control over the network.
- Section 3. **EFFECTIVITY**. This ordinance shall take effect immediately upon its approval.
