**MUNICIPAL ORDINANCE NO. 09-004**

**AN ORDINANCE AMENDING SECTION 5, ARTICLE VII OF MUNICIPAL ORDINANCE NO. 07-002, SERIES OF 2007, OTHERWISE KNOWN AS THE ZONING CODE OF LOON, BOHOL**

*Be it enacted by the 10th Sangguniang Bayan of Loon, Bohol in session duly assembled:*

**Section 1. AMENDATORY PROVISION:**

Section 5, Article VII of Municipal Ordinance No. 07-002, series of 2007 shall be amended to read:

**“Road Setback Regulations.** The following road setback regulations shall be applied from the center of the road:

<u>Zoning Classification</u>	<u>Major Road National</u>	<u>Secondary Province</u>	<u>Tertiary Mun./Bar.</u>
Residential	10 meters	10 meters	<b>5 METERS</b>
Commercial	<b>15 METERS</b>	<b>15 METERS</b>	<b>10 METERS</b>
Industrial	30 meters	25 meters	10 meters
Agricultural	20 meters	20 meters	7 meters
Agro-Industrial	30 meters	25 meters	10 meters
Institutional	20 meters	20 meters	10 meters
Parks and Recreation	10 meters	10 meters	<b>10 METERS</b>

Section 2.     **REPEALING CLAUSE.** This amendatory ordinance repeals portion of Section 5, Article 7 of Municipal Ordinance No. 07-002, otherwise known as the Zoning Code of Loon, Bohol

Section 3.     **EFFECTIVITY.** This ordinance shall take effect immediately upon its approval.
