AN ORDINANCE AMENDING THE TECHNICAL DESCRIPTION OF PANTUDLAN FISH SANCTUARY AS EMBODIED IN SECTION 3 (A) OF MUNICIPAL ORDINANCE NO. 99-005, SERIES OF 1999 AND THE SCOPE/TECHNICAL DESCRIPTION OF CABACUNGAN FISH SANCTUARY AS EMBODIED IN SECTION 3 OF MUNICIPAL ORDINANCE NO. 07, SERIES OF 1997

Be it enacted by the 10th Sangguniang Bayan of Loon, Bohol in session duly assembled:

Section 1. AMENDATORY PROVISIONS.

1.1 The Technical Description of Pantudlan Fish Sanctuary as embodied in Section 3 (a) of Municipal Ordinance No. 99-005, series of 1999 is hereby amended to read:
