**MUNICIPAL ORDINANCE NO. 10-007**  
Series of 2010

**AN ORDINANCE REQUIRING ALL DRIVERS OF TRICYCLES AND HABAL-HABAL/ MOTORCYCLES FOR HIRE TO SECURE HEALTH / MEDICAL CERTIFICATE BEFORE ALLOWING THEM TO SERVE THE RIDING PUBLIC WITHIN THE TERRITORIAL JURISDICTION OF LOON**

*Be it enacted by the 11<sup>th</sup> Sangguniang Bayan of Loon, Bohol session duly assembled:*

**Section 1. PROVISIONS.**

- 1.1. No person is allowed to drive any public utility tricycle or motorcycle for hire (habal-habal) without first submitting to the Office of the Mayor their Health / Medical Certificate duly signed by the Municipal Health Officer.
- 1.2. The components of Health Examination are: (a) eyesight of the driver (b) hearing capacity of the driver (c) physical condition of the driver
- 1.3. The drivers must observe their proper dress code with decency in transporting passengers.

**Section 2. RATIONALE.** Transporting passengers within the territorial jurisdiction of Loon requires extra-care by the tricycle and habal-habal drivers, otherwise, driving without medical clearances, even with driver's license, is inviting the riding public to any possibility of meeting a vehicular accident.

**Section 3. MAYOR'S PERMIT.** No permit shall be issued by the Mayor in consideration for the operation of any tricycle unit or habal-habal without attaching therein

the name of the driver with complete medical certificate issued by the Municipal Health Officer.

Section 4. PENALTY. Any violator shall be fined:

- a) First offense - P500.00
- b) Second offense - P1,000.00
- c) Third and succeeding offenses - P2,500.00

Section 5. ENFORCEMENT. The PNP Traffic Division, Municipal Traffic Aid (MUTRA), Auxiliary Police shall be tasked to enforce the provisions of this ordinance.

Section 6. DRIVER'S HEALTH ID. The Municipal Health Officer shall issue a Driver's Health ID for this purpose.

Section 7. SEPARABILITY CLAUSE. Any provision of this ordinance which maybe declared unconstitutional or void shall not affect the other provisions of this ordinance.

Section 8. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
