AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 10-006, SERIES OF 2010, ENTITLED: AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE OFFICER II (SG II) UNDER THE LGU-ECONOMIC ENTERPRISE OF LOON, BOHOL-

Be it ordained by the 11th Sangguniang Bayan of Loon, Bohol in session duly assembled:

Section 1. **AMENDATORY PROVISION.** Section 1, 2, 3, including the title of Municipal Ordinance No. 10-006, series of 2010 is hereby amended by inserting in parenthesis the terms "ADMINISTRATIVE OFFICER I" after the terms "ADMINISTRATIVE OFFICER II" to conform with Budget Circular No. 2004-3A, re: Conversion of Positions on Performing Staff / Non-Technicla Functions.

Section 2. **REPEALING CLAUSE.** Any ordinance or provisions contrary thereof are hereby repealed or modified accordingly.

Section 3. **EFFECTIVITY.** This ordinance shall take effect immediately upon its approval.
