MUNICIPAL ORDINANCE NO. 01-001
Series of 2001

AMENDING SECTION 2 OF MUNICIPAL ORDINANCE NO. 00-007, SERIES OF 2000, ABOLISHING AND CREATING CERTAIN POSITIONS IN THE 2000 PLANTILLA OF PERSONNEL OF THE MUNICIPAL GOVERNMENT OF LOON, BOHOL –

Be it ordained by the 7th Sangguniang Bayan of Loon, Bohol in session duly assembled, that:

SECTION 1. Section 2 of Municipal Ordinance No. 00-007, series of 2000 is hereby amended to read as follows:

“Section 2. Creation of Position – The following positions in the 2000 plantilla of Personnel of the Municipal Government of Loon, Bohol, are hereby created, viz:

- (1) One Social Welfare Officer IV (classified as Municipal Government Assistant Department Head) - SG 22
- (2) Two Utility Worker I - SG 1
- (3) Clerk II - SG 4

SECTION 2. RATIONALE. The amendments of Section 2, Municipal Ordinance No. 00-007, series of 2000 is pursuant to the PS requirement that the total amount of PS of the 4 positions proposed to be created will not exceed the total PS of the positions to be abolished.

SECTION 3. SPONSORSHIP. This ordinance was introduced by Honorable Vice Mayor Raul P. Barbarona and sponsored by the Committee in Good Government, Public Ethics and Accountability.

SECTION 4. EFFECTIVITY. This ordinance shall take effect upon its approval.
