## AN ORDINANCE CLASSSIFYING JOB ORDER EMPLOYEES AND FIXING THEIR DAILY MINIMUM WAGE -

(Author: Honorable Fortunato N. Garay)

Be it ordained by the 8<sup>th</sup> Sangguniang Bayan of Loon, Bohol in session duly assembled, that:

SECTION 1. Title – AN ORDINANCE CLASSSIFYING JOB ORDER EMPLOYEES AND FIXING THEIR DAILY MINIMUM WAGE.

SECTION 2. Principles & Objectives – It shall be the principles and objectives of the municipality:

- 2.1 That the poor and the needy are to be attended to for their tremendous hardships resulting from the deteriorating economic condition of the entire nation.
- 2.2 That there is a need to adopt the principle of unity in diversity by classifying job order employees of this municipality with their respective wages according to the standards of their work assignments.

## SECTION 3. Provisions.

3.1 There shall be a classification of job order workers with its corresponding salary scale.

## 3.2. Definition of Terms:

- a) Job Order Workers Those who are hired to work on seasonal or occasional basis.
- b) Job Order Workers Class A Those who are at least college graduates for office clerks.
- c) Job Order Workers Class B those with good moral character, physically fit and not bellow 18 years old.
- d) Job Order Workers Class C Those workers not below 15 years nor more than 60 years old but physically fit.
- e) Daily Wage An amount paid with high value of consideration by the municipality of Loon for an eight-hour work of the casual worker.

SECTION 4. Repealing Clause – All other ordinances inconsistent with this ordinance are hereby repealed.

SECTION 4. Effectivity – This ordinance shall take effect on April 1, 2002.
