AN ORDINANCE CREATING THE LOON SPORTS COMMISSION

(Author: Honorable Titus Clark Miranda)

Be it enacted by the 8th Sangguniang Bayan of Loon, Bohol duly assembled, that:

SECTION 1. Title – This ordinance shall be entitled: "AN ORDINANCE CREATING THE LOON SPORTS COMMISSION", otherwise known "Loon Sports Commission Ordinance."

SECTION 2. Purposes and Objectives – The following are the purposes and objectives in the creation of the Loon Sports Commission:

- a) To facilitate the formation of teams of the young generations of this town.
- b) To equip the sports-minded generations on the sports facilities thru the guiding efforts of the commission.
- c) To promote sports and develop the talents of the Loonanon young generations towards the scene of sports popularity, thereby gaining prestige to this town.
- d) To develop the spirit of sportsmanship.

SECTION 3. Composition – There shall be created the Loon Sports Commission which shall be composed of the following:

- a) Chairman The Municipal Mayor.
- b) Co-Chairman Vice Mayor.
- c) Vice-Chairman SKMF President
- d) Members The two (2) District Supervisors of the Department of Education in the municipality.
 - Presidents of sports associations or organizations in the Municipality.
 - A representative from each private high school in the Municipality.
 - The President of the Association of Barangay Captains in the Municipality.
 - The Chairman of SB Committee on Sports.
 - The Chairman of SB Committee on Games and Amusement.

SECTION 4. Sports/Games – The Commission shall introduce, and if possible, to specialize the following sports/games:

- a) chess
- b) boxing
- c) basketball
- d) softball
- e) volleyball
- f) football
- g) tennis
- h) badminton
- i) pingpong
- i) billiard
- k) judo
- I) weightlifting
- m)swimming
- n) cycling
- o) high jump
- p) 100-meter dash
- q) taekwando
- r) sepa takraw
- s) bowling
- t) dart
- u) other sports/games or activities which the Commission deems necessary

SECTION 5. Category – The kinds of sports/games shall be divided into three categories:

- a) Elementary Division students aging 7-12 years old.
- b) High School Division students or out of school youths aging 13-16 years old.
- c) College Division students or out of school youths aging 17-21 years old.

SECTION 6. Sports Levels – There shall be three levels in the municipal sports promotion system:

- a) Barangay level to be conducted every third week of October and every Christmas Vacation, annually.
- b) District level to be conducted every April annually, per district of the town.
- c) Municipal level to be conducted every May annually in the municipal level.
- d) Championship level shall be conducted on the first week of September.

SECTION 7. Budget Allocations.

- a) Barangay level shall be shouldered by the barangay SK funds.
- b) District level $-\frac{1}{2}$ shall be shouldered by the barangays composing the district and $\frac{1}{2}$ shall be shouldered by the municipality.
- c) Municipal and Championship level shall be shouldered by the municipality.

SECTION 8. Powers and Functions of the Loon Sports Commission – The following are the powers and functions of the Loon Sports Commission:

- a) to supervise the conduct of mass-based sports promotion system in this municipality.
- b) To coordinate the 67 barangays thru their respective SK Chairmen and Barangay Officials, Purok Leaders for the success of the sports promotion system.
- c) To supervise the scheduling of the games from barangay to championship level.
- d) To coordinate with the private/business sector for possible co-sponsorship to any sports activities which maybe made through a Memorandum of Agreement (MOA) entered into by the Municipality through the Commission and the business sector.
- e) To coordinate with all other government or non-government agencies for the total development of the young Loonanons in the field of sports.
- f) Provide such incentives, recognition and awards to deserving associations, athletes, coaches, trainor and other persons or entities involved in or supporting sports development as may be permissible under the rules of amateurism.

- g) The Commission shall meet once every quarter.
- h) The Commission shall submit to the Budget Officer the Budget Proposal for the succeeding year activity for the inclusion in the executive budget on July 16 in every calendar year the budget proposal for the succeeding year activity.

SECTION 9. Effectivity – This ordinance shall take effect immediately upon its approval.
