Request for Expression of Interest CONSULTING SERVICES ENGAGING THE SERVICES OF AN ISO CERTIFICATION BODY FOR CERTIFICATION OF ISO 9001:2015 QUALITY MANAGEMENT SYSTEM

- 1. The Local Government Unit of Loon, Bohol, through the General Fund intends to apply the sum of Eight Hundred Ten Thousand Pesos (₱ 810,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Engaging the Services of an ISO Certifying Body for Certification of ISO 9001:2015 Quality Management System. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
- The Local Government Unit of Loon, Bohol now calls for the submission of eligibility documents for Consulting Services for the project. Eligibility documents of interested consultants must be duly received by the BAC Secretariat.

Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 IRR of RA 9184. The consultants shall drop **three (3) copies** of their duly accomplished eligibility requirements in sealed envelopes in the above-mentioned address.

Prospective bidders must submit their Eligibility Documents not later than 8:30 AM on March 5, 2025 at the Office of the Bids and Awards Committee (BAC), Municipal Hall, Cogon Norte, Loon, Bohol.

3. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The criteria and rating system for short listing are:

Passing Rate is 70%.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. The bids will be evaluated using Quality-Cost Based Evaluation/Selection procedure. The criteria and rating system for the evaluation of bids will be provided in the Instructions to Bidders. Only bids whose technical proposals pass the minimum technical evaluation score of seventy-five (75%) shall have their financial proposals opened and evaluated.
- The contract shall be completed within Three years (3) (2025-2027) from the issuance
 of the Notice to Proceed. Bid documents will be available only to eligible and shortlisted
 consultants upon payment of non-refundable fee in the amount of FIVE HUNDRED
 PESOS (P500.00) only.
- 6. The Office of the Bids and Awards Committee reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
