### **MUNICIPAL ORDINANCE NO. 24-002**

Series of 2024

AN ORDINANCE AMENDING SECTION 6.2 C AND SECTION 8 WITH ADDITIONAL PROVISION OF MUNICIPAL ORDINANCE NO. 17-009 SERIES OF 2017, ENTITLED: "AN ORDINANCE REGULATING THE OPERATION, MANAGEMENT AND DEVELOPMENT OF LOON PUBLIC MARKETS OF THE MUNICIPALITY OF LOON"

Be it ordained by the 15th Sangguniang Bayan of Loon on session duly assembled:

**SECTION 1.** Section 6.2 C of Municipal Ordinance No. 17-009 Series of 2017 shall be amended to read:

- 1. A) All Restaurants/Carenderias occupying stalls C-1, C-2, C-3, C-4 and C-5 of Block C shall be transferred to the newly built building designated as Block O, stalls O-1, O-2, O-3, O-4 and O-5, at the back portion of Mercado de Loon. Provided, that the existing stall occupant/s is/are in good standing. Raffle draw shall be done with owners of the existing Restaurants/Carenderias for individual stall assignment at the relocation Block O.
- 1. **B)** The stalls namely C-1, C-2, C-3, C-4 and C-5 of Block C shall be converted into Cereals and Sari-Sari Sections.
- 1. C) The Right To Occupy And Fix Daily Rental Fees of Restaurants/ Carenderias Section shall be as follows:

**SECTION 2.** Section 8 of Municipal Ordinance No. 17-009 Series of 2017 shall be amended by to read:

- **2. A**) There shall be designated areas for food preparation and cooking areas outside the public market with usage fee of P500.00/month with an area of 6 square meters (2x3 meters) for Carenderias/ Restaurants.
- 2. B) The Loon Public Market Council through the Market Administrator is hereby mandated to allocate an annual budget for payment of insurance coverage premium for Mercado de Loon and other satellite/ extension market buildings and facilities.

# SECTION 3. PROHIBITION ON SELLING OF RAW FISH/ SEAFOOD PRODUCTS OUTSIDE THE LOON PUBLIC MARKET.

- No person shall be allowed to display and sell raw fish/ seafood products, except the
  fisherfolks on occasional basis, authorized lessee and vendor of the same products,
  within two (2) kilometers radius at any time from any government operated public
  market.
- 2. The use of any sound amplifier or any related microphone sound system by any ambulant vendor or fixed stall vendor in displaying and marketing of the goods shall be prohibited anywhere, regardless of the distance from the public market, within the territorial jurisdiction of the municipality of Loon.
- 3. Violation of any provision of this section is punishable with a penalty of One Thousand Five Hundred pesos (P 1, 500.00) per offense.

**SECTION 4. REPEALING CLAUSE**. Municipal Ordinance No 17-009 series of 2017 is hereby repealed or amended accordingly.

SECTION 5. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.
